Bahrke's Fruitdale Addition, also along the East side of Seventh Street adjacent to the West 96 feet of the South 132.75 feet of Blk 24, A.F. Bahrke's Fruitdale Addition to Lebanon, Oregon.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY
OF LEBANON:

That the property owner, or owners, of the West Side of Williams Street from the S.E. Corner of Lot 3, Blk 4, Center Addition, South a Distance of 120 feet, also along the West side of 10th St. adjacent to Lot 10, Blk 2, Green Acres Addition, also along the East side of 7th St. adjacent to Lot 5, Blk 12, Hyland Addition, also along the West side of 2nd St. adjacent to Lot 4, Parkview Subdivision, also along the East side of Main St. adjacent to the West 100 feet of the South 22 feet of Lot 8, Blk 12, Ralston's Third Addition, also along North side of Maple St. adjacent to the East 72 feet of the West 128 feet of the South 132.17 feet of Blk 26, A.F. Bahrke's Fruitdale Addition, also along the East side of Seventh Street adjacent to the West 96 feet of the South 132.75 feet of Blk 24, A.F. Bahrke's Fruitdale Addition to Lebanon, Oregon, be and they hereby are, ordered to construct and repair a sidewalk and related structures along the West Side of Williams Street from the S.E. SAid construction shall be in accordance with Ordinance No. 1311, and shall be in accordance with current

construction standards of the City of Lebanon, and that said sidewalk and related structures shall be built within the time period established by the procedures outlined in Ordinance No. 1311, and that said time period shall not be greater than 60 days from the passage of the Resolution.


