Ralston's Addition, also along the East Side of Grove Street adjacent to Lot 4, Blk 2 of the Queen Anne Addition, also East Side of Grove Street adjacent to Lot 5, Blk 2 of the Queen Anne Addition, also along East Side of Grove Street adjacent to Lot 1, Blk 2 of Queen Anne

Addition, also East Side of Hiatt Street of Lot 8600 of Linn County Assessors Office, also South Side of Oak Street adjacent to Tax Lot 6200 of Linn County Assessors Office, also Western side of Second Street adjacent to Lot 7 of Supp. Plat No. 2 of Strawberry Subdivision, also South Side of Oak Street and the West Side of Seventh Street adjacent to Lot 5, Blk 15 of the Hyland Addition.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON:

That the property owner, or owners of the West Side of Grove Street adjacent to Lot 2, Blk 21 of J. M. Ralston's Addition, also along the East Side of Grove Street and the North Side of Grant Street adjacent to the westernmost one-half of Lots 5 and 6, Blk 26 J. M. Ralston's Addition, also along the East Side of Grove Street adjacent to Lot 6, Blk 25 of J. M. Ralston's Addition, also along the East Side of Grove Street adjacent to westernmost 109 feet of Lot 5, Blk 25 of J. M. Ralston's Addition, also along the East Side of Grove Street adjacent to Lot 4, Blk 2 of the Queen Anne Addition, also East Side of Grove Street adjacent to Lot 5, Blk 2 of the Queen Anne Addition, also along East Side of Grove Street adjacent to Lot 1, Blk 2 of Queen Anne Addition, also East side of Hiatt Street of Lot 8600 of Linn County Assessors Office, also South side of Oak Street adjacent to Tax Lot 6200 of Linn County Assessors Office, also Western side of Second Street adjacent to Lot 7 of Supp. Plat No. 2 of Strawberry division, also South Side of Oak Street and the West Side of Seventh Street adjacent to Lot 5, Blk 15 of the Hyland Addition. Said construction shall be in accordance with Ordinance No. 1311, and shall be in accordance with current construction standards of the City of Lebanon, and that said sidewalk and related structures shall be built within the time period established by the procedures outlined in Ordinance No. 1311, and that said time period shall not be greater than 60 days from the passage of the Resolution.


