WHEREAS, the City Engineer has recommended that parking be eliminated on a portion of the East side of Fifth Street adjacent to Tax Lots 3100 and 8301; and on the West side of Fifth Street adjacent to Tax Lots 1900 and 3200; and on the North side of Olive Street adjacent to Tax Lot 2300; and on the East side of Third Street adjacent to Tax Lot 4200; and on the West side of Second Street adjacent to Tax Lot 1200; and on the East side of Second Street adjacent to Tax Lot 3700; and on the North side of Jennings Street adjacent to Tax Lot 8100; and on the North side of Olive Street adjacent to Tax Lot 2000; and on the South side of Olive Street adjacent to Tax Lot 3400; and on the East side of Main Street adjacent to Tax Lot 2100; and on the West side of Main Street adjacent to Tax Lot 2000; and on the South side of Rose Street adjacent to Tax Lot 3900; and on the North side of Oak Street adjacent to Tax Lot 1000; and on the North side of Oak Street adjacent to Tax Lot 1500; and on the South side of Oak Street adjacent to Tax Lot 1900; and on the East side of Grove Street adjacent to Tax Lot 7700; and on the West side of Williams adjacent to Tax Lot 7000; and on the North side of Milton adjacent to Tax Lot 10800; and

WHEREAS, such regulation is deemed to be reasonable and necessary for the safe movement of traffic in the City of Lebanon.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON, AS FOLLOWS:

Section 1: Parking is hereby prohibited along approximately 20 ft. of curbing on the East side of Fifth Street adjacent to Tax Lots 3100 and 8301; and 20 ft. on the West side of Fifth Street adjacent to Tax Lots 1900 and 3200; and 50 ft. on the North side of Olive Street adjacent to Tax Lot 2300; and 30 ft. along the East side of Third Street adjacent to Tax Lot 4200; and 26 ft. on West side of Second Street adjacent to Tax Lot 1200; and 50 ft. on the East side of Second Street adjacent to Tax Lot 3700; and 11 ft. on the North side of Jennings Street adjacent to Tax Lot 8100; and 50 ft. on the North side of Olive Street adjacent to Tax Lot 2000; and 50 ft. on the South side of Olive Street adjacent to Tax Lot 3400; and 30 ft. on the East side of Main Street adjacent to Tax Lot 2100; and 50 ft. on the West side of Main Street

adjacent to Tax Lot 2000; and 25 ft. on the South side of Rose Street adjacent to Tax Lot 3900; and 50 ft. on the North side of Oak Street adjacent to Tax Lot 1000; and 45 ft. on the North side of Oak Street adjacent to Tax Lot 1500; and 100 ft. on the South side of Oak Street adjacent to Tax Lot 1900; and 20 ft. on the East side of Grove Street adjacent to Tax Lot 7700; and 50 ft. on the West side of Williams adjacent to Tax Lot 7000; and 50 ft. on the North side of Milton adjacent to Tax Lot 10800.
