BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON,

WHEREAS, the labor contracts negotiated between the City of Lebanon and the International Association of Firefighters, AFL-CIO, Local 2163, and the American Federation of State, County and Municipal Employees, AFL-CIO Local 2043-A, were multi-year contracts with an automatic opening clause during the second year of the contract if the Portland Area Consumer Price Index exceeded seven percent (7%), and

WHEREAS, the Consumer Price Index from October 1976 to October 1977 was 8.2%; negotiations with the aforementioned parties did take place, and

WHEREAS, a cost of living increase of seven percent (7%) was agreed upon by both the City of Lebanon and the aforementioned unions, now therefore,

The Mayor and City Recorder of the City of Lebanon are hereby authorized and directed to sign an addendum to the labor contracts with the aforementioned unions for a cost of living increase of seven percent (7%) for the fiscal year 1978-79. A copy of said addendums are attached hereto and made a part hereof.
