



BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:


Section 1. That the Mayor and Recorder of the City of Lebanon are hereby authorized and directed to enter into an agreement with Linn County, Oregon concerning the City of Lebanon's Preliminary Urban Growth Boundary and the City's request for amendment thereto. A copy of said agreement is attached hereto and made a part hereof.

AGREEMENT

THIS AGREEMENT, made and entered into this 25th day of April, 1979, by and between the City of Lebanon, Oregon and Linn County, Oregon.

WITNESSETH:

WHEREAS, the City of Lebanon and Linn County entered into an intergovernmental agreement for the establishment of a Preliminary Urban Growth Boundary on July 12, 1978; and

WHEREAS, this Agreement contains provisions for the amendment of the Preliminary Urban Growth Boundary after review and recommendation by the City and County Planning Commissions and formal action by the Lebanon City Council and the Board of Linn County Commissioners; and

WHEREAS, the City initiated a request for amendment to the Urban Growth Boundary of the following described property: Tax Lots 1800 and 1900, Tax Map 12-2W-3B and Tax Lot 100 12-2W-4 (plus Gore Road), which is further described pictorially by Exhibits "A" and "B", which by this reference are incorporated herein; and

WHEREAS, the required public hearings before the Lebanon City Council and the Linn County Board of Commissioners have been held; and

WHEREAS, the amendment request had been previously referred and a recommendation received from the City of Lebanon and Linn County Planning Commission; and

WHEREAS, on April 11, 1979, the Linn County Board of Commissioners formally adopted the amendment to the Lebanon Preliminary Urban Growth Boundary and the City of Lebanon formally agreed to the County's recommended change.

NOW, THEREFORE, IT IS HEREBY AGREED by and between the parties hereto as follows:

The Lebanon Preliminary Urban Growth Boundary is amended to include that property hereinbefore described.

AMENDMENT TO PRELIMINARY URBAN GROWTH BOUNDARY FOR LEBANON

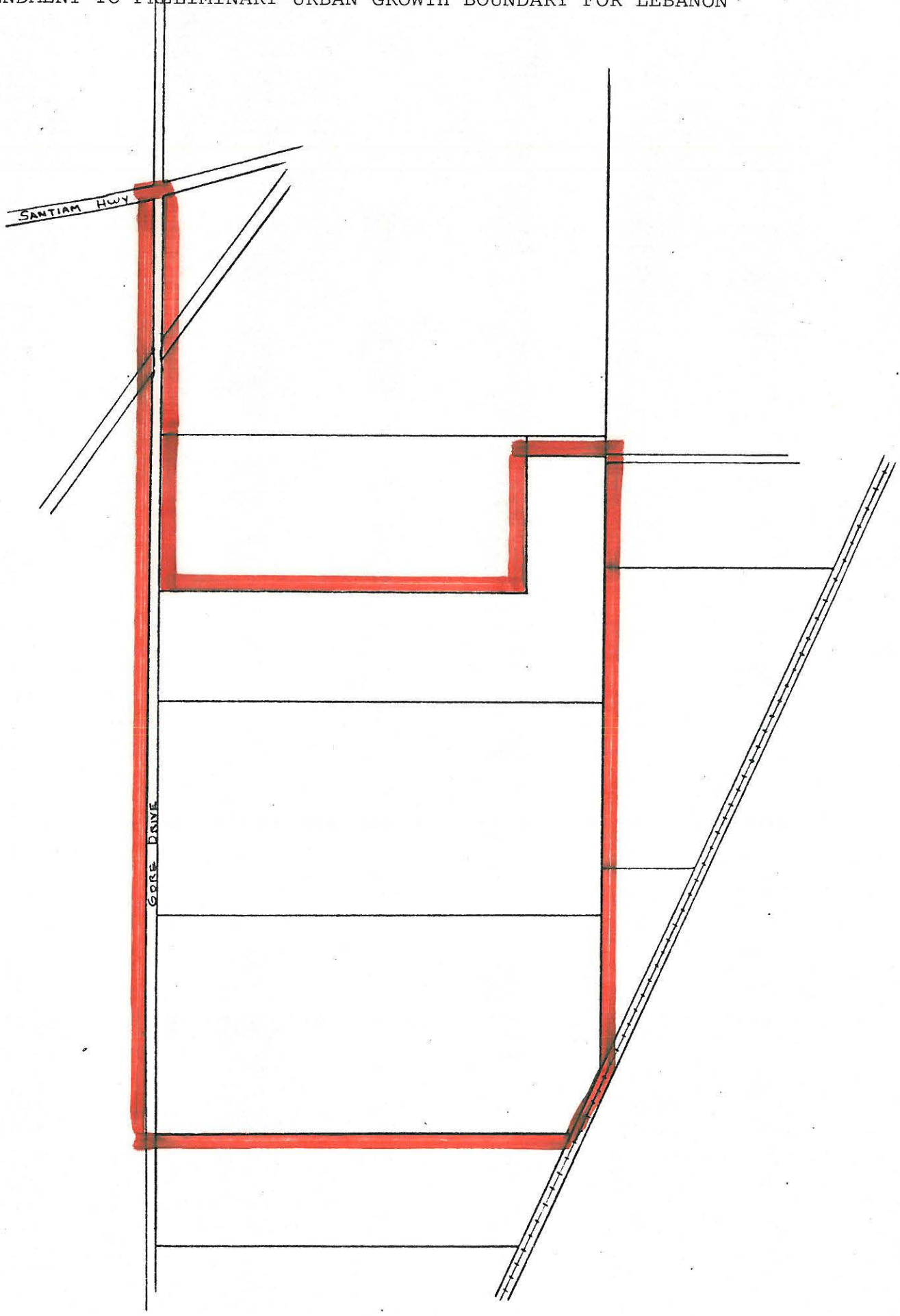


EXHIBIT "B"
