RESOLUTION NO. 15
for 1982

WHEREAS, the owners of property within the Gilbert Drive Local Improvement District (L.I.D.) boundaries have filed with the City Recorder of the City of Lebanon, Oregon, their petition asking for sanitary sewer improvements; and

WHEREAS, the City Council of the City of Lebanon has established and administered said L.I.D. in the manner set forth in Ordinance No. 1681, Chapter 12, Lebanon Municipal Code, and as provided by law; and


WHEREAS, the City Engineer has recommended that the costs outlined in Appendix A, attached hereto and compiled in accordance with said Ordinance No. 1681, be attributed to and charged against said L.I.D.; and

WHEREAS, said costs are deemed reasonable and necessary for the improvements associated with said L.I.D.; NOW, THEREFORE,

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:


Section 1. The cost for construction of the sanitary sewer extension serving the Gilbert Drive Local Improvement District to be assessed on benefiting properties is \$79,648.14.
