

A RESOLUTION ESTABLISHING)
SEWER USE RATES.)

RESOLUTION NO. 21
for 1983

WHEREAS, the City Council of the City of Lebanon did on June 24, 1981 adopt Ordinance No.1852 providing that the sewer use rates should be established by Resolution; and,

WHEREAS, new fees have been proposed as shown in the following rate schedule;

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:

Section 1. Effective July 1, 1983, the sewer use fees shall be as follows:

SEWER USE FEE SCHEDULE

DOMESTIC USER RATES

For each domestic user, the monthly sewage charge is based upon the following formula as outlined in Section 3.B of Ordinance 1852:

A = B + DE	<u>Rate</u>
where: A = Monthly sewage charge	
B = Standby charge	= \$ 2.00
D = Average of 3 months water consumption	
E = Consumption rate	= \$ 1.27/100 cubic feet
The basic fee to account for users who are not served by Pacific Power and Light Company's water system and do not wish to install a meter on their water service line shall be	\$10.89 per living unit

COMMERCIAL USER RATES

For each commercial user, the monthly sewage charge is based upon the following formula as outlined in Section 3.C of Ordinance 1852:

A = B + DE	<u>Rate</u>
where: A = Monthly sewage charge	
B = Standby charge	= \$ 2.00
D = Average of 3 months water consumption	
E = Consumption rate	= \$ 1.27/100 cubic feet

SCHOOLS

For each school, the monthly sewage rate is based upon the following formula as outlined in Section 3.D of Ordinance 1852:

A = FG	<u>Rate</u>
where: A = Monthly sewage charge	
F = Total student enrollment	
G = Sewerage charge per student	\$ 0.38

INDUSTRIAL USER RATES

For each industrial user, the monthly sewage rate is based upon the following formula as outlined in Section 3.E of Ordinance 1852:

$I = (TSS) J + (BOD) K + L + (Q) M$	<u>Fee</u>
where: I = Monthly sewage charge	
TSS = Total Suspended Solids per month	
J = Use charge for TSS	\$ 0.085 per pound
BOD = Total Biochemical Oxygen demand per month	
K = Use charge for BOD	\$ 0.17 per pound
L = Demand charge	see below
Q = Monthly discharge flow	
M = Consumption rate	\$ 1.27/100 cubic feet

The monthly demand charge for the following industries are hereby established:

Linn Gear Company	\$80.00
Lebanon Community Hospital	\$80.00


Section 2. This Resolution supersedes and replaces Resolution No.33 for 1982, passed July 28, 1982.
