This agreement is by and between the Regional Automated Info	ormation Network (RAIN).

Under the terms of this agreement, the Agency warrants that it is a Member Criminal Justice Agency as defined in the RAIN Membership Contract of August 12, 1975, which is by reference hereby incorporated into and made a part of this agreement.

The Agency and the CITY OF LEBANON further agree: further agree:

- 1. To abide by all published rules, policies and procedures promulgated by RAIN governing the administration of the RAIN System.
- 2. That it is warranted that all personnel have, or will be, so screened as to prohibit access to any RAIN records by persons so restricted in the following Section 3.
- 3. That no person who has been convicted of a crime which could have resulted in a sentence to a federal or state penitentiary will be allowed to operate a terminal or otherwise have access to RAIN information, and that requests for extraordinary circumstance exceptions to this requirement will be promptly submitted, in writing, to the RAIN Board Chairman, and acted upon in the affirmative by RAIN.
- 4. That any RAIN terminal equipment assigned to the Agency will be installed and maintained in a secure location in the Agency facility.

All parties mutually agree that:

Justice Agencies.

- 1. Violation of any provision of this agreement, or any published rules, policies or procedures promulgated by RAIN governing the operation of the RAIN System, may cause immediate suspension of the Agency's authorization to access RAIN information. Reinstatement will be effected only upon demonstration by the Agency that the cause of such violation has been corrected. Final determination as to the reinstatement of any Agency so suspended will be the responsibility of the RAIN Executive Committee.
- 2. That each Criminal Justice Agency administrator establish a policy, in writing, to ensure that no person or persons will have access to or be able to view any information from the RAIN terminal equipment, without first having proper authorization from the Criminal Justice Agency administrator.

- 3. Any contested action relating to this agreement will be conducted under provisions established by the RAIN Policy Board.
- 4. This agreement may be cancelled by any party hereto, upon thirty days notice in writing, directed to all parties subscribing hereto.
