

A RESOLUTION ESTABLISHING)
WATER USE RATES)

RESOLUTION NO. 20
for 1985

WHEREAS, the City Council of the City of Lebanon did on November 28, 1984, adopt an amendment to the Municipal Code providing that Water Use rates should be established by Resolution; and,

WHEREAS, fees have been proposed as shown in the following rate schedule;

NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:

Section 1. Effective June 1, 1985, the water use fees shall be as follows:

WATER USE FEE SCHEDULE

Domestic Service Charge

For each domestic account a monthly service charge shall be assessed as follows:

<u>Basic Charge</u>	<u>Size of Meter</u>
\$ 6.25	3/4" or less
8.45	1"
12.65	1 1/4"
18.90	1 1/2"
33.65	2"

Commodity Charge

\$2.12 per 100 cu. ft. for the first 600 cu. ft.

\$1.06 per 100 cu. ft. for all additional cu. ft.

COMMERCIAL AND INDUSTRIAL SERVICE CHARGE

For each Commercial or Industrial account a monthly service charge shall be assessed as follows:

<u>Minimum Charge</u>	<u>Size of Meter</u>
\$ 12.12	3/4" or less
16.38	1"
24.58	1 1/4"
36.57	1 1/2"
65.26	2"
119.60	3"
206.65	4"
391.55	6"

Commodity Charge

\$3.11 per 100 cu. ft. for the first 1,200 cu. ft. per inch of meter size.

1.18 per 100 cu. ft. for the next 1,200 cu. ft. per inch of meter size.

0.80 per 100 cu. ft. for all additional cu. ft.

Note: The size of the 1,200 cu. ft. blocks are for a 1-inch meter and will be increased or decreased for for each 1/4-inch of meter size but in no event will said blocks be reduced below those for a 3/4"-inch meter.

PRIVATE FIRE PROTECTION SERVICE CHARGE

For each Private Fire Protection Service account a monthly service charge shall be assessed as follows:

For Privately Owned and Maintained Hydrants

\$ 4.15 for each 2" connection or smaller
5.60 for each 4" connection
9.15 for each 6"
14.75 for each 8"

For City Owned and Maintained Hydrants

\$ 7.80 for each 4" hydrant (nominal size)

350	1"
970	1 1/2"
1,100	2"

Turn On Charge \$ 20.00 during normal working hours
40.00 after normal working hours

Service Deposit \$ 60.00

\$ 12.50 - One time cost, per service address
