RESOLUTION NO. 8
for 1986 _____

WHEREAS: Construction of rural-standard street improvements along portions of Second Street and South Main Rd. has left a clear hazard to the substantial pedestrian traffic thereon; and

WHEREAS: City of Lebanon Ordinance No. 1895 places the responsibility for sidewalk construction with the adjacent property owner. Said Ordinance also enables the City Council to order construction of sidewalks where it deems reasonable, necessary and expedient; NOW THEREFORE


BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:

Section 1. Owners of properties abutting the South Main Road project improvements and listed in Appendix A of this Resolution are hereby directed to cause the construction of sidewalks along the frontage of said properties.

Section 2. Said sidewalks shall be constructed in accordance with specifications set forth by the City Engineer and shall be completed prior to November 1, 1986.

Section 3. The City Engineer is hereby directed to notify affected property owners of the action hereinabove ordered.

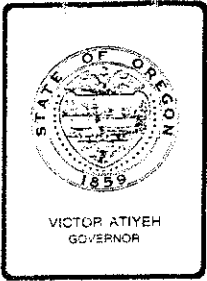

Gentlemen & Ladies:

The Oregon State Highway Division (State) and the City of Lebanon (City) entered into an agreement, dated November 4, 1955, concerning installation of traffic control signals at the intersection of:

Main and Ash Streets
Main and Sherman Streets
Main and Grant Streets
Park and Grant Streets

State and City have now determined that the aforementioned agreement, although remaining in full force and effect, should be supplemented by this agreement in the manner hereinafter set forth in order to change maintenance responsibilities. Any further reference to the agreement of November 4, 1955 shall include the following provisions:

STATE OBLIGATIONS

State shall, at its own expense, maintain the subject traffic signals.

City shall adopt a resolution authorizing its designated city officials to enter into and execute this agreement, and a copy of such resolution shall be attached hereto and become a part hereof.

IN WITNESS WHEREOF, the parties hereto have set their hands and affixed their seals as of the day and year hereinafter ffixed their seals as of the day and year hereinafter written.

The Oregon State Highway Commission is now designated the Oregon Transportation Commission.

The Oregon Transportation Commission, by a duly adopted delegation order, authorized the State Highway Engineer to sign this agreement for and on behalf of the Commission. Such authority is set forth in the Minutes of the Oregon Transportation Commission.
