  - 0.80 per 100 cu. ft. for all aditional cu. ft.

Note: The size of the 1,200 cu. ft. blocks are for a 1-inch meter and will be increased or decreased for each 1/4-inch of meter size but in no event will said blocks be reduced below those for a 3/4"-inch meter.

## STANDBY WATER SERVICE CHARGE

For all Residential, Commercial, or Industrial Standby Water Services the charge shall be:

Note: Should the water use for a Standby Water Service exceed 1 unit in any one meter read period the service charge will resort to the standard Residential or Commercial rate as appropriate for that month.

#### PRIVATE FIRE PROTECTION SERVICE CHARGE

For each Private Fire Protection Service account a monthly service charge shall be assessed as follows:

## For Privately Owned and Maintained Hydrants

- \$ 4.15 for each 2" connection or smaller
  - 5.60 for each 4" connection
  - 9.15 for each 6"
- 14.75 for each 8"

# For City Owned and Maintained Hydrants

\$ 7.80 for each 4" hydrant (nominal size)
