PARKING IN THE CITY OF LEBANON

RESOLUTION NO. 7
for 1988

WHEREAS, the City Engineer has recommended that parking be restricted to Handicap Loading Only on a portion of Harrison Street; and

WHEREAS, the City Engineer has recommended that parking be restricted to 15 min. Temporary Parking on a portion of Harrison Street; and

WHEREAS, such regulation is deemed to be reasonable and necessary for the safe movement of traffic in the City of Lebanon.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LEBANON AS FOLLOWS:

Parking is hereby restricted except for the purpose of loading and unloading Handicapped Passengers Only between the hours of 9:00 A.M. and 2:00 P.M. Monday through Friday in the following described area;


- 1) In the parallel parking stalls located on the South side of Harrison Street, between Second Street and Third Street, more specifically described as that curbside parking area on the South side of Harrison Street beginning 211 feet West of the West side curb line of Second Street and extending Westward 30 feet.

Parking is hereby restricted to 15 minute Parking Only between the hours of 9:00 A.M. and 2:00 P.M. Monday through Friday in the following described area;


- 1) In the parallel parking stalls located on the South side of Harrison Street, between Second Street and Third Street, more specifically described as that curbside parking area on the South side of Harrison Street beginning 241 feet West of the West side curb line of Second Street and extending Westward 43 feet.

Suitable signs shall be erected and/or markings may be painted in the appropriate places; and such description shall be part of the traffic regulations of the City of Lebanon, Oregon.

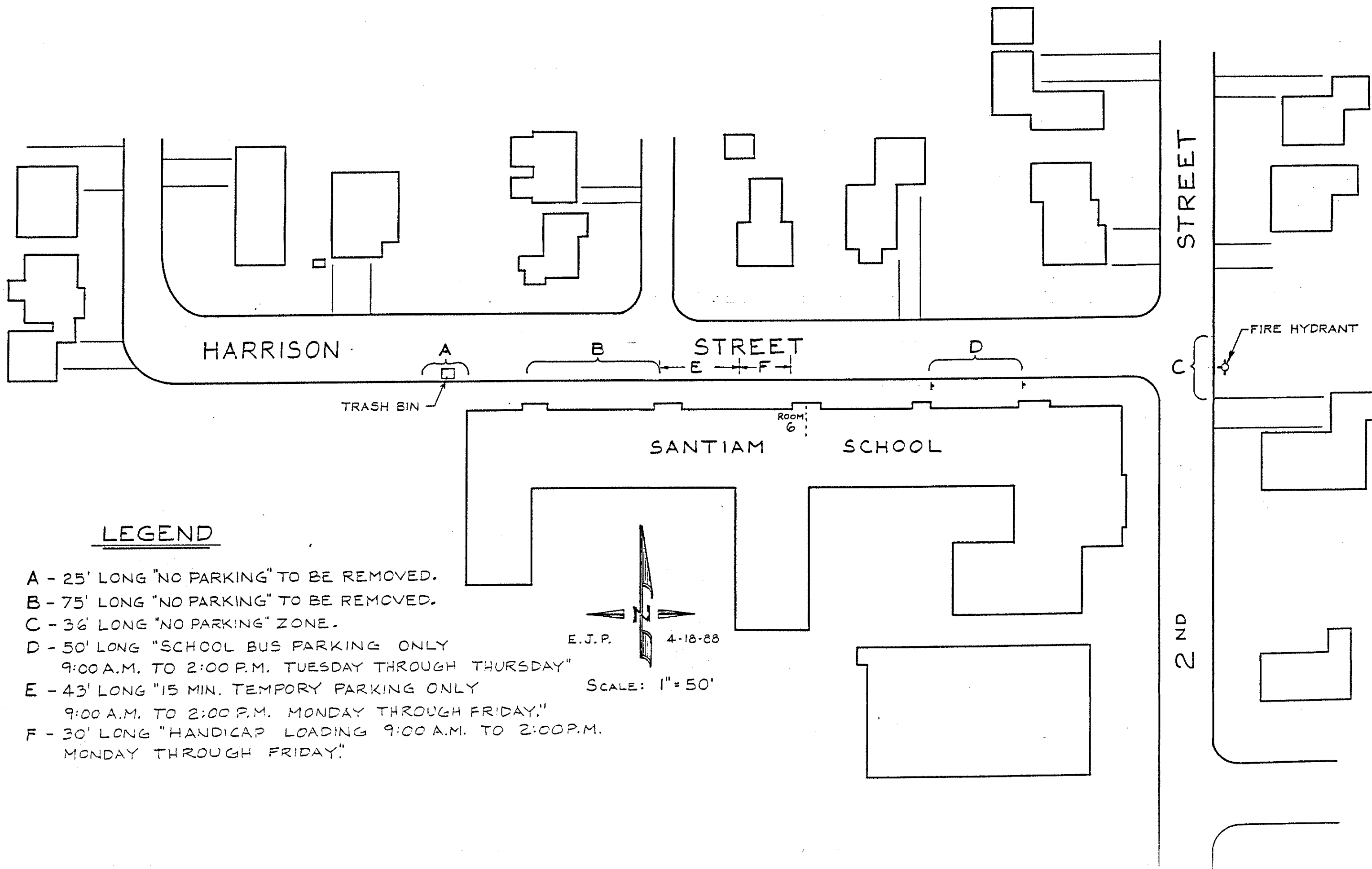
Passed by the Council by a vote of 6 for and 0 against, and approved by the Mayor this 27th day of April, 1988.
