

A RESOLUTION WITHDRAWING CERTAIN) RESOLUTION No. 52
TERRITORY FROM THE CITY OF LEBANON.) for 1991

WHEREAS, on September 25, 1991, the City Council for the City of Lebanon approved Resolution No. 46 for 1991 to initiate the withdrawal of certain territory, described in said Resolution as Exhibit "A"; and

WHEREAS, the City Council, after lawful notice, conducted a public hearing on the withdrawal of said territory on October 23, 1991; and the City Council having considered the testimony at said public hearing and having determined that it is in the best interests of the citizens of the City of Lebanon to withdraw said territory, and having entered an order scheduling a final hearing on such Resolution; and the City Council finding that appropriate notice has been made for the final hearing on Resolution No. 48 for 1991; and the City Council having conducted a final hearing upon the Resolution for withdrawal and finding that the required number of written requests for an election on the proposed withdrawal have not been filed;

NOW, THEREFORE, it is hereby resolved as follows:

Section 1. It is hereby declared that the territory described in Exhibit "A" of Resolution No. 46 for 1991, and further described as Exhibit "A" of this Resolution, attached hereto and incorporated herein by reference, is and shall be detached and withdrawn from the City of Lebanon.

Section 2. A true and certified copy of this Resolution, certified as such by the City Recorder, shall be forwarded the Board of Commissioners for Linn County, Oregon.


Section 3. This Resolution shall be effective upon its passage.

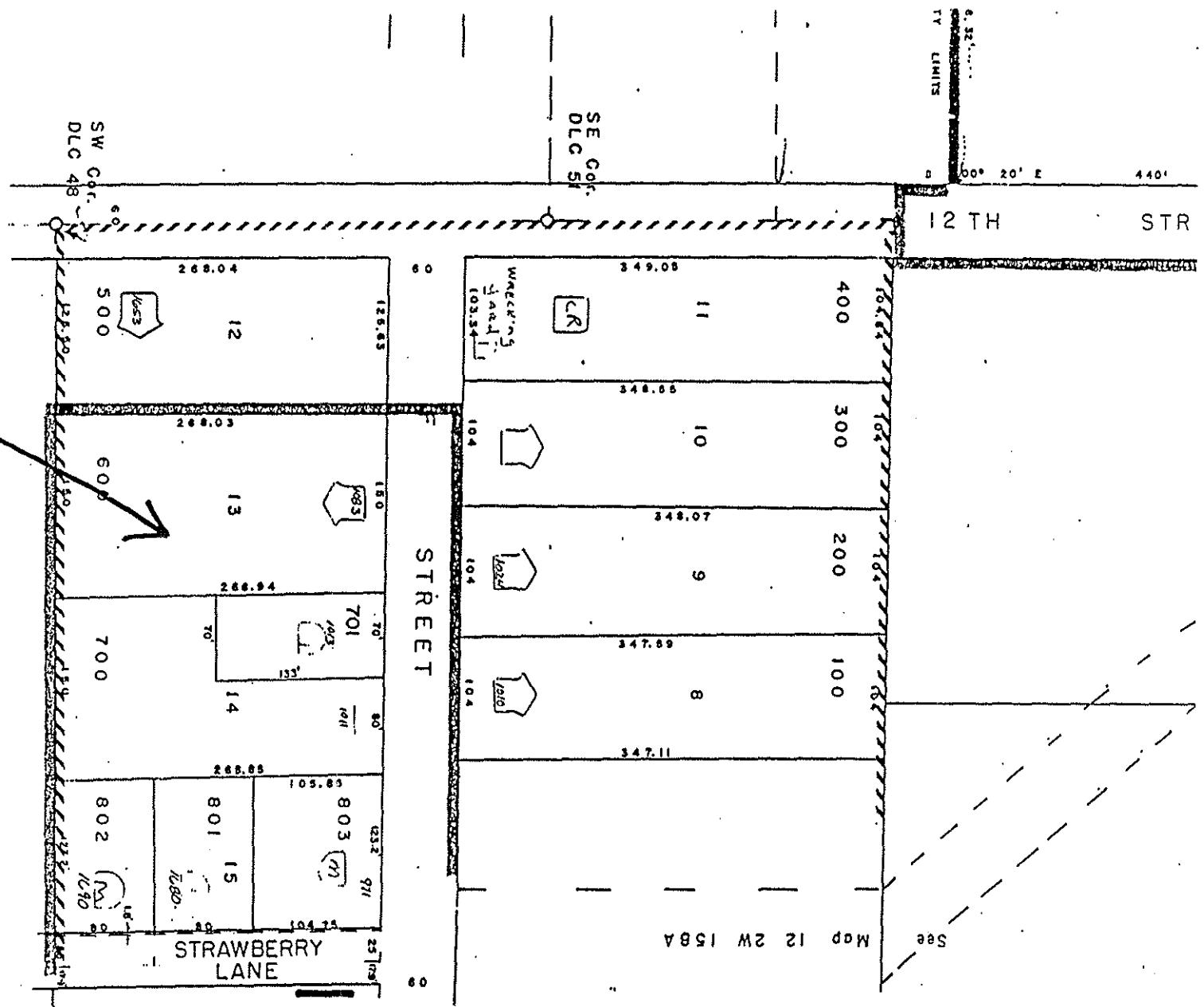
