

A RESOLUTION ESTABLISHING A FEE
STRUCTURE FOR THE OPERATION OF
OF THE LEBANON DIAL-A-BUS

WHEREAS, the City of Lebanon operates, for the benefit of its citizens, and particularly its senior and disabled citizens, a bus to provide transportation for citizens; and

WHEREAS, the City of Lebanon has experienced diminution in the funding for the operation of the Dial-A-Bus program; and

WHEREAS, the City of Lebanon has determined that a fee schedule should be adopted to help fund the Dial-A-Bus program; and

WHEREAS, the City of Lebanon has determined that a fee schedule should take into consideration a citizen's ability to pay the fee;

NOW, THEREFORE, BE IT RESOLVED by the City of Lebanon as follows:

Section 1. The City hereby adopts the Lebanon Dial-A-Bus fee structure which is attached hereto as Exhibit "A" and incorporated herein by this reference.

Section 2. The City hereby characterizes the adoption of this fee as not being subject to the limits of Section 11b, Article XI, of the Oregon Constitution.

Section 3. The City Administrator of the City of Lebanon is hereby ordered to publish, within 15 days after the adoption of this resolution, in a newspaper of general circulation in Linn County, a notice complying with ORS 305.583(8) of the adoption of this resolution.


Section 4. The fees adopted by this resolution in Section 1 shall be effective August 1, 1995.

Passed by the Council of the City of Lebanon by a vote of 5 for and 0 against, and approved by the Mayor this 14th day of June, 1995.
