Section 2. The City Recorder is ordered to enter said assessment in the docket of city liens, and upon such entry being made, it shall constitute a lien upon the property described herein.

Section 3. The assessment made herein shall be enforced in the same manner as liens for street improvements are enforced and shall bear interest at the rate of ten percent yearly.

Section 4. This Resolution shall become effective immediately upon its passage.
