

Ordinance Bill No 104 Ordinance No 100

An Ordinance Providing for the opening of certain streets in the city of Lebanon for the naming of the same and the dedicating of the said streets

The people of the city of Lebanon do ordain as follows

Sect
1

whereas the Common Council does it for the best interest of the people of the city of Lebanon and its inhabitants to open dedicate and name certain streets within the said city and it appearing that a majority of the property owners adjacent to the said proposed streets have filed with the recorder a petition praying for the opening dedicating and naming of the said streets over along and upon the following described lines and premises ~~and~~ same to be of the width as herein set out to wit

Beginning at the Southeast corner of Block No 5 in Center Addition to Lebanon in Linn County Oregon and running thence South 227 feet - thence East 60 feet - thence North 227 feet - thence to the South West corner of Block 4 in said center addition to Lebanon thence west 60 feet - the place of beginning the same being an extension of Grove Street in said city and to be a street 60 feet wide and to be known as Grove Street

Also Beginning at a point the North West corner of lot No 14 in Home Addition to Lebanon in Linn County Oregon thence west parallel with the South boundary line of the donation land claim of Wm Ralston 20 chains to the East boundary line of Main Street in said Ralston's Addition to Lebanon in Linn County Oregon thence north along the East boundary line of said main street 110 feet - thence East parallel with the South boundary line of said Wm Ralston's donation land claim 20 chains to the South

west corner of lot - no 13 in Said Home Addition to Lebanon in Linn County Oregon thence South 40 feet to the place of beginning the same being an extension of Milton Street in Said Home Addition and to be a Street - 40 feet wide and to be known as Milton Street -

Also Beginning in the East boundary line of main Street in William Palston's Addition to Lebanon in Linn County Oregon at a point which is North 1380 feet distant from the South boundary line of the donation land Claim of William Palston Claim No 48 in Township No 12 South of Range No 2 West of the Willamette meridian Oregon and running thence East - parallel with the South boundary line of Said Claim No 48, 27 chains to the East - boundary line of Said Claim No 48 thence North 40 feet thence west parallel with the South boundary line of Said Claim No 48, 27 chains to the East boundary line of Said main Street thence South 40 feet to place of beginning the same being an extension of Elmore Street in Said Home Addition and to be a Street 40 feet wide and to be known as Elmore Street -

That the City of Lebanon Linn County Oregon deem it for the best interest of the said city and its inhabitants to lay out - open - dedicate and name certain Streets in the said city over along and upon the route and premises and land hereinbefore and herein after described and that the said Streets when so laid out opened and dedicated and named be public Streets of the said city and under the jurisdiction and supervision of the Common Council of the said city as other Streets of said city

Sec 2 That the lines dimension and route of the said Streets be along over and upon the following route, to wit
 Beginning at a point the South East Corner of Block No 5 in center addition to Lebanon in Linn County Oregon and running thence South 227 feet - thence East 60 feet - thence north 227 feet to the South west corner of Block No 4 in said center addition to Lebanon thence west 60 feet - to the place of beginning and all the land embraced within said description be used and dedicated and appropriated for a street it being the intention to open a street 60 feet wide over and upon the said route the same to be known as Grove Street
 Also to lay out open and dedicate a street as follows

Beginning at the northwest corner of Lot 14 in Home addition to Lebanon Linn County Oregon thence west parallel with ^{the} South boundary line of the donation land claim of William Ralston's 20 chains to the East boundary line of Main Street in Wm Ralston's addition to Lebanon Linn County Oregon thence East north along the East boundary line of said main Street 40 feet thence East parallel with the South line of said Wm Ralston donation land claim 20 chains to the South west corner of lot No 13 in said Home addition to Lebanon ~~the said street to be known as Milton Street~~ thence ^{40 feet} South to the place of beginning the said street to be known as Milton Street and that all the said land embraced within the said description be used dedicated and appropriated for a public street

Also to lay out open and dedicate a street over along and upon the following route to wit
 Beginning on the East line of main Street in William Ralston's addition to Lebanon in Linn County Oregon at a point which is north 1380 feet distance from the South boundary

line of the donation land claim of W^m Palston claim No 48 in Township 12 South of Range No 2 west of the Willamette meridian Oregon and running thence East parallel with the South boundary line of said claim No 45 27 chains to the East boundary line of the said claim No 48 thence North 40 feet thence west parallel with the South boundary line of said claim No 48 27 chains to East boundary line of said main street thence South 40 feet to place of beginning the said street to be 40 feet wide and to be known as Elmore Street all of the said streets being in the city of Lebanon in Linn County Oregon

3

That notice of the proposal of the said city of Lebanon Oregon to lay out open name and dedicate the said streets be given by publication thereof in the Lebanon News papers published weekly in Lebanon in Linn County Oregon and of general circulation therefore four weeks and that a copy of the said notice be posted in four public places in the said city and a copy thereof be served on the owners or ~~reputed~~ reputed owners of the abutting property on the said proposed streets or in the said proposed streets at least ten days prior to the time fixed and set for the hearing of the said matter before the said City Council

That the said Council fixes and set as the time and place for hearing any and all objection and remonstrances against the laying out opening naming and dedicating of the said streets as herein set out on the 7th day of February 1911 at the Council chambers in said City of Lebanon at the hour of 8 o'clock P M of the said day the same being a regular meeting of the said Council and at the said time and place viewers and appraisers be named

and appointed view out and assess any and all benefits and damages to any abutting adjacent to other property by reason of the laying out opening and dedicating of the said proposed streets and to determine and do all other things necessary and required to be done in the matter and premises
