Ordinance Bill No 109

Ordinance 105

An Ordinance Providing for the Construction of a Wooden Side walk abutting upon and on the South Side of Block 5-five in Wassons Addition to Lebanon Oregon and abutting on lots 5-6-7 and 8 in said <sup>since block 5 in</sup> addition and providing that the costs of same shall be a lien upon the said property and declaring an emergency

The People of the City of Lebanon do <sup>organize as follows,</sup>  
That there shall be constructed a wooden side walk 5 1/3 feet wide on the South Side of and abutting on block Five in Wassons addition at the expense and the costs of the owners of the South half of the said Block the same being lots 5-6-7 and 8 in said block 5 in said Wassons Addition to the City of Lebanon, in Linn County, Oregon, and the Mayor and the Recorder of the said city be and they are hereby empowered authorized and directed to enter into and sign on behalf of the city of Lebanon, a written Articles of Agreement for the Construction of said Side walk provided that the said Contract and Agreement shall not be entered into or signed on behalf of the said city until after the proposals for the Construction of said wooden Sidewalk have been advertised for in the manner of awarding Contracts and bids have been received and considered by the Council and the award of the Contract by the Council and the costs and expenses of the Construction of the same have been ascertained, fixed and determined by the Council

2

That the costs and expenses of the Construction of the said Sidewalk shall be made a lien upon and against the said lots 5-6-7 and 8 in said block 5 in Wassons Addition to Lebanon, the same being the lots adjacent to ~~the~~ <sup>and</sup> abutting upon the said proposed Side walk.

Sec  
3 That the Recorder shall at once proceed to advertise for sealed bids for the construction of the said sidewalk and the same be opened at the regular council meeting to be held on July 18<sup>th</sup> 1911 at 8 o'clock P.M. of said day at the Council chambers in the city of Lebanon.

Sec  
4 That in as much as the city is in need of the early construction of the said sidewalk and the safety, peace and health of the of the said city requires that the same be made and constructed as soon as possible an emergency is hereby declared to exist and this ordinance shall be in full force and effect from and after its passage by the Council and its approval by the Mayor.

Passed by the Council this 20<sup>th</sup> day of June 1911 the same having received the unanimous vote of all the members elected to the Council taken by ayes and noes
