ORDINANCE NO. 132

An Ordinance providing for the opening, extending and widening Franklin Street from Elmore Street to southern limits of the City of Lebanon,, and for the opening of Grove Street from Center Addition to Elmore Street in the City of Lebanon, and for the opening and extending Vine Street from Third Street ~~xxxKifkxSixxax~~ ^{west} West to Smith First Addition to Lebanon, and for opening and widening of Hiatt Street from Grant Street north to Burtenshaw' Addition to Lebanon, and provide for the establishing of the grades of the said streets when so opening and declaring an emergency.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:-

WHEREAS, the common council of the said City of Lebanon deem it expediant and for the best interest of the said City of Lebanon and its inhabitants to open, lay out, extend, widen and establish certain streets in the City of Lebanon, Oregon, over, along, through and upon the following route and property, to-wit:-

GROVE STREET 60 FEET WIDE,

as follows:-

Beginning at the South west corner of Lot 6 in Block 4 in Center Addition to Lebanon, Oregon, and running thence South on a line parallel with Grove street to the north line of Elmore Street; thence ~~xxxx~~ West 60 feet; thence North on a line parallel with grove street to the South East corner of lot 8 in said Center Addition; thence East 60 feet to the place of beginning,

The said tract and parcel of land above described to be a public street 60 feet wide and to be known and designated as Grove Street in the City of Lebanon, Oregon,

FRANKLIN STREET 50 FEET WIDE

as follows:-

Beginning at the South East corner of Lot 8 in Home Addition to Lebanon, Oregon, and running thence South to the southern limits of the City of Lebanon; thence East 50 feet; thence North on a line parallel with Franklin Street as now established, if extending South to the South line of Elmore Street; thence West 30 feet to the east line of Franklin Street as now located and established as a 20 foot street; thence South along the east line of said Franklin Street to a point 20 feet east of the place of beginning; thence West 20 feet to the

place of beginning.

That the said tract and parcel of land together with Franklin street as now located and established along the east line of Home Addition as a street 20 feet wide be and constitute a public street 50 feet wide in the said City of Lebanon and to be known and designated as Franklin street.

Also to locate and widen and extend a street as follows:-

HIATT STREET 60 FEET WIDE,

over, upon, through and along the following route and property to-wit:-

Beginning at a point which is 60 feet South of the South west corner of Lot 6 in Block 3 in Burtenshaw's Addition to Lebanon, Oregon, and running thence South to the north line of Grant street in said City; thence westerly along the north line of said Grant street 30 feet; thence North to Sherman street; thence East 30 feet to the place of beginning, t

That said tract and parcel of land to be used to widen Hiatt Street from Grant Street to Sherman street from a 30 foot street to a 60 foot street, and the said land together with said Hiatt street between said Grant Street and Sherman Street as now located and established as a 30 foot street to be and constitute a public street in the said City of Lebanon, Oregon, 60 feet wide and to be known and designated as Hiatt Street.

Also to locate establish and extend a street as follows:-

VINE STREET 60 FEET WIDE,

over, upon, along and through the following route and property, to-wit:-

Beginning at a point which is 60 feet west of the South west corner of Block 18 in Ralston's Third Addition to Lebanon, Oregon and running thence West to the South East corner of Lot 7 in Block 3 in Smith's First Addition to Lebanon, Oregon; thence South 60 feet to the North East corner of Lot 3 in Block 4 in said Smith's First Addition to Lebanon; thence East to ~~xxxxxxx xxxxx~~ a point 60 feet west of the North West corner of Block 19 in Ralston's Third Addition to Lebanon; thence North 60 feet to the place of Beginning;

the said tract and parcel of Land to be and constitute a public street 60 feet wide, over, upon, along and through the said above described land, and to be designated and known as Vine Street in the city of Lebanon, Oregon.

SECTION 1.

That the common Council of the City of Lebanon, Oregon deem it expedient and for the best interest of the said City and its inhabitants to lay out, open, widen and extend the following streets in the said City ~~along~~, over, upon and through the following property, land and route to-wit:-

GROVE STREET 60 FEET WIDE

as follows:

Beginning at the South west corner of lot 6 in Block 4 in Center Addition to Lebanon, Oregon, and running thence South on a line parallel with Grove street to the north line of Elmore street; thence West 60 feet; thence ~~North~~ ^{North} on a line parallel with Grove street to the South East corner of Lot 8 in ~~said~~ Center Addition; thence East 60 feet to the place of beginning,

The said tract and parcel of land to be and constitute a public street 60 feet wide in the city of Lebanon and to be known and designated as Grove street in said City.

FRANKLIN STREET 50 FEET WIDE,

AS FOLLOWS:-

Beginning at the South East corner of Lot 8 in Home Addition to Lebanon, Oregon, and running thence South to the southern limits of the City of Lebanon; thence East 50 feet; thence North on a line parallel with Franklin Street as now established, if extended South, to the South line of Elmore street; thence West 30 feet to the east line of Franklin Street as now located and established as a 20 foot street; thence South along the east line of said Franklin street to a point 20 feet east of the place of beginning; thence west 20 feet to the place of beginning,

That the said tract and parcel of land together with Franklin street as now located and established along the east line of Home Addition ~~Addit~~ Addition to said Lebanon as a street 20 feet wide be and constitute a public street in the ~~said~~ city 50 feet wide to be known and designated as Franklin Street.

HIATT STREET 60 FEET WIDE,

as follows-

Beginning at a point which is 60 feet south of the South west corner of lot 6 in Block 3 in Buttemshaw's Addition to Lebanon, Oregon, and running thence South to the north line of Grant street in said city; thence westerly along the north line of said Grant street 30 feet; thence North to Sherman Street; thence East 30 feet to the place of beginning.

That the said tract and parcel of land together with said Hiatt

street between Grant Street and Sherman street as now located and established as a street 30 feet wide be and constitute a public street 60 feet wide and to be known and designated as Hiatt street.

VINE STREET 60 FEET WIDE,

as follows:

Beginning at a point which is 60 feet West of the South west corner of Block 18 in Ralston's Third Addition to Lebanonm Oregon, and running thence West to the South East corner of Lot 7 in Block 3 in Smith's First Addition to Lebanon, Oregon, thence South 60 feet to the North East corner of Lot 3 in Block 4 in said Smith's First Addition, to Lebanon, thence East to a point 60 feet west of the North West corner of Block 19 in said Ralston's Thrd Addition to Lebanon; thence North 60 feet to the place of beginning.

That said tract and parcel of land to be and constitute a ^{public} street 60 feet wide in the said city of Lebanon and be designated and known as Vine Street.

SECTION 2

That the said streets and each and all of them, and any of them when so laid out, established and opened be under the jurisdiction of the common council of the said City of Lebanon and the superintendent of streets of the said city, the same as other public streets of the said City, and that the grades of the said streets or any of them be established in the same manner as the grades of other streets are established, and that the said grades correspond to the grades of the abutting streets."

SECTION 3.

That notice of the proposal and intention of the said city to locate open and establish the said streets, and to widen and and extend the sam be given by publication thereof in the Lebanon Criterion a newspaper published in Lebanon in Linn County, Oregon and of general circulation, once a week for four consecutive weeks, and a copy of the said notice be served on the owners or reputed owners of the land to be taken and appropriated for such streets at least ten days prior to the time and date set by the council for hearing the said matter, and also be posting four copies of the said notice in four public places in the said city.

SECTIONN 4

That the council fixe and sets the 16th day of September 1913


at the hour of 8 o'clock p. m. of said day at the council chambers in the city of Lebanon as the time and place for hearing any and all objection and remonstrances against the laying out, locating and establishing of the said streets or any of them, and the appropriating the said land for such streets, the same time and place being a regular meeting of the said Council.

SECTION 5.

That in as much as it is necessary that the said streets be improved without delay and that health, safety and peace of the said city requires that this ordinance be in full force and effect at once an emergency is hereby declared to exist, this ordinance shall be in full force and effect from and after its passage by the council and approval by the mayor.

Passed by the council this 5th day of August, 1913 the same having received the affirmative vote ~~xxx~~ of all members elected to the council taken by aye and nay vote upon the roll being called and the vote taken and entered in the journal of the council.
