An Ordinance authorizing and directing the issuance and sale of improvement bonds of the City of Lebanon, Linn County, Oregon, for the improvement of Grant street from the East line of Second street to Park street, by paving the same with Gravel Bitulithic pavement, in accordance with the Charter of the said City and the provisions of Sections 5245 to 3253 inclusive, of Chapter 5 of Title XXVI of Lord's Oregon Laws, and acts amendatory thereof, in the sum of \$4741.84 the same being the total amount of the unpaid assessments for such improvement of said street, for which applications to pay in installments have been filed with the Recorder of the said City of Lebanon.

Whereas the Common Council of the City of Lebanon, Oregon, has improved Grant street from the East line of Second street to Park street in the City of Lebanon, Oregon by paving the same with Gravel Bitulithic pavement by Ordinance No. 133, duly enacted and passed by the Council on the 5th day of June, 1913, and approved by the Mayor on the 5th day of June, 1913, and by the final assessment Ordinance No. 139 duly enacted and passed by the Council on the 11th day of November, 1913, and approved by the Mayor on the 11th day of November, 1913, and approved by the Mayor on the 11th day of November, 1913, in accordance with the plans and specifications, duly and regularly adopted for the improvement of said street and

Whereas within 10 days after the notice of such assessment was first published, there were filed with the Recorder of the said City of Lebanon, Oregon, written applications to pay said assessments, levied upon and against the property adjacent and abutting upon said improvement and the property particularly and specially benefited thereby, in installments and

Whereas the said applicants and property owners did thereby waive

any and all irregularities, defects, jurisdictional or otherwise, in the proceedings to improve the said street for which said assessments were levied and in proportionment of the cost thereof and,

Whereas said applicants and property owners agreed in said applications to pay said assessments in 10 annual installments with interest at the same rate, on all said assessments which have not been paid, as that expressed in the bonds issued to pay for such improvement and,

Whereas said applications contain a statement and description, by lots or blocks or other convenient description of property of the applicants assessed for such improvement, and in all respects have complied with the requirements of said Chapter 5 of Title XXVI of Lord's Oregon Laws, togetherwith the name of the applicant and owner of such property and the amount of unpaid assessment against each lot or part of lot or tract or piece or parcel of land, which said name of owner, description and amount is as follows, to-wit:

Whereas the total amount of the unpaid assessments for such improvement for said street, for which applications to pay under the provisions of said act above referred to as shown by said Bond Lien Docket, is the sum of \$4741.84,

Now THEREFORE THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS: Sec. 1. That the Mayor and Recorder of the City of Lebanon, Oregon, are hereby authorized, empowered and directed to sign and execute on behalf of the said City, its negotiable, interest bearing, coupon bonds and issue its bonds, in all equal to the amount of \$4741.84 the said sum being the total amount of the unpaid assessments for such street improvement for the said street for which applications to pay, under the provisions of Chapter 5 of Title XXVI of Lord's Oregon Laws, have been filed with the Recorder of the said City as shown by the Bond Lien Docket of the said City, which said bonds shall be numbered from 1 to 10 both inclusive, and shall be in denominations of \$500.00 each, except the bond bearing the number 10, being the highest number of said bonds, which shall be for the sum of \$241.84. Sec. 2. That the said bonds shall bear the date of December 1, 1913 and shall, by the terms, mature in 10 years from the date thereof and shall be payable in gold coin of the United States of America, and bear interest at the rate of 6% per annum, interest payable semi-annually, said interest to be evidenced by a coupon attached to said bonds, which must have a number printed or engraved thereon agreeing to the number of the bond, both principal and interest to be payable at the office of the City Treasurer of Lebanon, Oregon.

Sec. 3. That the right to take up and cancel such bond or bonds upon the payment of the face value thereof, with accrued interest to date of payment, at any semi-annual coupon period at or after one year from the date of such bond or bonds, is hereby reserved, said redemption of such bonds, if so made, to be in accordance with the provisions of said Chapter 5 of Title XXVI of Lord's Oregon Laws.

Sec. 4. That such bonds, before the issuance thereof, shall be signed by the Mayor and countersigned by the Recorder of the City of Lebanon, Oregon, and authenticated by the seal of said City, and the coupons shall bear the signatures of the Mayor and Recorder, but such names may be printed or engraved thereon, and such bonds shall be registered consecutively by number and denomination of each, in a book to be kept by the Recorder for that purpose, to be numbered and designated as the Improvement Bond Register.

Sec. 5. That each of the said bonds shall have plainly printed, inscribed or engraved on the face thereof, a registered number and the words "Improvement Bond" with the name of the City of Lebanon, Oregon. Sec. 6. That the said bonds shall be advertised for sale for a period of 10 days from the date of first publication and shall be sold for the highest price obtainable by not less than par and accrued interest, and the proceeds of such sale shall be paid by the purchaser to the Treasurer of the City of Lebanon, and the par value thereof and interest credited to the street improvement funds for which said bonds are issued, and the premium thereon, if any, from the sale of such bonds shall be credited to the general fund of the City.

Sec. 7. That the said bonds and coupons shall be substantially in the following form:

IMPROVEMENT BONDS No. Know all men by these presents, that the City of Lebanon in the County of Linn, State of Oregon, for value received, hereby promises and agrees to pay to the bearer, the sum of \$500.00 in gold coin of the United States of America, on presentation and surrender of this obligation, on the 1st day of December, in the Year of Our Lord Nineteen-Hundred-and-Twenty-Three, without grace, with interest thereon from the date hereof, until redeemable, at a rate of 6% per annum payable semiannually in like gold coin, on the 1st day of June and the 1st day of December in each year, on presentation and surrender of the proper coupon hereunto annexed, principal and interest payable at the office of Treasurer of the City of Lebanon, Oregon; this bond is one of a series authorized by an act of the Legislative Assembly of the State of Oregon, as contained in Chapter 5 of Title XXVI of Lord's Oregon Laws and acts amendatory thereof, and is an obligation of the City of Lebanon, Oregon and is not to be deemed or taken to be within or any part of the limitation by law as to the indebtedness of the said City of Lebanon, and it is further certified that all requirements of law and the Charter of the said City have been fully complied with by the proper officers in the issuing of this bond, and the total amount of this issue does not exceed the limit prescribed by the said act; this bond is redeemable at the office of Treasurer of the said City, at the option of the City of Lebanon, upon the payment of face value thereof with accrued interest to the date of payment, at any semi-annual coupon period at or after one year from date hereof as provided in said act.

For the fulfillment of the conditions of this obligation, the faith and credit of the City of Lebanon are hereby pledged in witness hereof; this bond has been signed by the Mayor and attested by the Recorder of the City of Lebanon, and the Corporate seal of the said City of Lebanon hereto affixed this 200 day of _____
