A BILL FOR AN ORDINANCE.

ORDINANCE NO. 150 .

An Ordinance concerning the carrying of intoxicating liquor through or upon the streets, alleys or other public places in the City of Lebanon, Oregon.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful to carry, haul or convey through or upon any street, alley, avenue or other public place within the corporate limits of the City of Lebanon, Oregon, any intoxicating liquors of any kind, except in the sealed packages, with seals unbroken, in which such liquor was originally shipped into said City, and excepting also sealed packages lawfully sold by a duly licensed pharmacist, on prescription.

Section 2. It shall be unlawful for any druggist or pharmacist to sell any intoxicating liquor on
prescription without placing a seal over the cork of the
bottle in which the same is delivered, in such manner that
the cork cannot be removed from the bottle without breaking such seal.

Section 3. Whenever any peace officer of the City of Lebanon, or of the County of Linn, has reasonable grounds to believe that any person or persons are violating any of the provisions of Section 1 of this ordinance, said peace officer shall have power to search such person or persons, and the things carried by, and the conveyance being used by, such person or persons; and, in case any intoxicating liquors are found being carried, hauled or conveyed in violation of Section 1 of this ordinance, Ordinance, p. 1.

such intoxicating liquors, together with the person or persons violating said Section 1 hereof, shall be forthwith taken by said officer before the City Recorder of said City, and a complaint shall be filed against such person or persons by said peace officer.

Section 4. Any person violating any of the provisions of this ordinance shall, upon conviction thereof, be punished by a fine of not less than twenty-five dollars (\$25) nor more than two hundred dollars (\$200), or by imprisonment in the city jail not less than ten (10) days nor more than fifty (50) days, or by both such fine and imprisonment in the discretion of the court; and, in case of such conviction, all intoxicating liquors found to have been carried, hauled or conveyed in violation of this ordinance, shall be publicly destroyed.

Section 5. That, in the opinion of the Council, this ordinance is required by the peace, health and safety of the City of Lebanon, for the reason that the freight records show that a considerable amount of intoxicating liquor is being shipped into said City, and the peace officers find great difficulty in enforcing the local option haw and liquor ordinances in said city; therefore, an emergency is hereby declared to exist, and this ordinance shall be in full force and effect at once upon its approval by the Mayor.
