ORDINANCE BILL No. 4 for 1915.

ORDINANCE NO. 184.

An Ordinance to fix the compensation of certain officers of the City of Lebanon, Oregon, and to repeal Ordinance No. 95.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. The Marshal of the City of Lebanon,
Oregon, shall receive a salary of \$65.00 per month, to be
paid monthly as other bills against the City are paid, which
amount shall be in full for all services rendered to said
City by him as such officer; and in addition to the duties
as a police officer, he shall perform such other duties as
the Council shall require, provided that, when required to
perform the duties of Superintendent of Streets and Plumbing
Irepeator, he shall receive \$10.00 per month additional on
account of such added duties.

Section 2. The Recorder of the City of Lebanon,
Oregon, shall receive a salary of \$300.00 per year, payable
monthly or quarterly as other bills against the City are paid,
which sum shall be in full for all services rendered by him
as such officer, whether as clerk of the Council, police judge,
or for issuing licenses or other clerical work in connection
with said office. All fees and fines collected by said Recorder shall be turned over to the City Treasurer, as provided
by law and the City Charter, and said Recorder shall make and
file a report at the end of each quarter of all moneys collected
by him.

Section 3. The Treasurer of the City of Lebanon,
Oregon, shall receive a salary of \$120.00 per year, payable
monthly or quarterly as other bills against the City are paid,

which amount shall be in full for all services rendered to the City by him as such officer.

Section 4. The City Attorney of the City of Lebanon, Oregon, shall receive a salary of \$300.00 per year, payable monthly or quarterly as other bills against the City are paid, which amount shall be in full for all general services rendered by him to the City as counsel for the City officers and prosecuting all cases in the City courts; provided, however, that the Council may allow such other sums as shall be reasonable for extraordinary services, litigation in State or other outside courts, and necessary business trips outside the City.

Section 5. The Health Officer of the City of Lebanon, Oregon, shall receive a salary of 10.00 per year for his services as such officer, and shall also receive the sum of 1.50 for each necessary visit made to any sick person who is under the care or treatment of the City, said sums to be allowed and paid as other bills against the City.

Section 5. All officers of said City whose salaries are herein provided for shall perform all the duties now provided by the Charter and Ordinances of said City for such officers, or that may hereafter be provided for them to perform by the Council of said City, and they shall not receive, directly or indirectly, any other fees or compensation for any work or services than herein provided for their services as such officers.

Section 7. Ordinance No. 95 of said City, entitled "An Ordinance to fix the compensation of certain officers of the City of Lebanon, Linn County, Oregon", passed by the Council on the 4th day of December, 1909, and approved by the Mayor of the 8th day of December, 1909, is hereby repealed.
