And WHEREAS, the Committee of Street and public property have made 9 examination of proper flushed and have examined the quality and 10 prices of same, and they are of the opinion the "ECOMOMY" Flusher 11 is the best adapted to the needs and requirements of the said Cit 12 of tebanon, and that the same is offered at as low a price as a 13 good flusher can be purchased for, Therefore. 14 THE PEOPLE OF THE CITY OF LEBANOW DO ORDAIN AS FOLLOWS. 15 Section 1:- That the Mayor of the said City of Lebanon is hereby 16 directed and authbrized to purshage and pay one ECOMOMY Street 17 Flusher, from the Ecomomy Street Flusher Company of Shenandoah 18 Iowa, for and at the price of \$750.00 on boars the cars at Cmaha, 19 Rebraska, and the said Mayor is further directed and authorized to 20 pay the freight at regular charges from said Omaha to rebanon, 21 Oregon, in addition to the said price of \$750.00. the said sums 22 to be paid in cas on the arival of the said Flusher in Lebanon, 23 Oregon in good condition, the same having arived in such condition. 24 Section 2:- In as much as the city at this time has no street 25 flusher, and the health and peace of the city requires that 26 the street be put in and kept in a clean and healtful condition, ATTORNEY-AT-LAW
