That no original license shall be issued until the applicant therefor shall have first made application in writing to the license committee of the Common Council of the City of Lebanon, Oregon, in which said application such applicant shall state fully the business or things to be done or perfarmed under such license, the place where the business is to be done or carried on, and the time or term for which the license is desired. If the said committee approve of the same and the said business or things to be done, and that the business or things to be done will be carried on according to law, they shall endorse on the said application their approval, and reccommend that that the license be granted to the applicant. The said applicant shall thereupon present the said application with the said endorsement together with a receipt from the city treasurer for payment in full of the amount of the license required for the said full term of the said license, whereupon the said recorder shall issue to the said applicant a license which shall authorize the said applicant to carry on and conduct the said business calling and things provided for in the said application and license
