3	An Ordinance to regulate and license the selling of cigarettes,
4	Cigarette wrappers and cigarette paper in the city of Lebanon,
5	Oregon, and to puhish any violation of this Ordinance.

7	THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:-
8	Section 1 It shall be unlowful for any demon within the
9	Section 1. It shall be unlawful for any person within the
10	city of Lebanon, Oregon, to sell, or give to any minor di-
11	rectly or indirectly, any cigarette or Cigarettes, or any ci-
12	garette wrapper or cigarette paper, or any other material used
13	for cigarettes or in making cigarettes.

15	Section 2. Any person or persons, company, association, or
16	corporation selling cigarettes, cigarette wrapping paper, or
17	cigaratte paper or any other things or material used in the
18	making of cigarettes shall pay an annual license on the sum of
19	\$ 60.00, the said license to be paid quarterly as other li-
20	censes of the city are paid, the quarter license to be one-fourt
21	of the annual license, and no license shall be issued for less
22	than a quarter, except the original license which shall be issued
23	for the balance of the current quarter for the pro rata part of
24	the quarter.

26	Section 3. It shall be unlawful for any person, persons, compa-
27	ny, association or corporation, to sell, deal in or give away
28	to any person, ditectly or indirectly, within the limits of the
29	city of Lebanon, Oregon, any cigarette or Cigarettes, cigarette
30	wrappers or cigarette paper or any other substance or material
31	used in the making of cigarettes, without first having procur-

ed and paid for a license therefor as herein provided.

1 Section 4. Any person, persons, Company, Association or corporation, selling any cigarettes, cigarette wrapping paper or 3 cigarette paper, or any other substance or material used in the 4 making of any cigarette to any minor, or selling the same to any 5 other person without first having procured a license for that 6 purpose as herein provided, or violating any of the provisions of this ordinance shall upon conviction thereof before the re-8 corders Court of the City of Lebanon be punished by a fine of 9 not less than \$10.00 nor more than \$100.00, or by imprison-10 ment in the city jail not less than five days nor more than 11 fifty days, or by both such fine and imprisonment .. 12 13 14 15

Section 5. In order that dealers may dispose of the stocks of cigarettes on hand this ordinance shall be in full force and effect from and after July 25, 1917, and the same shall not be in force or effective until the close of the 25th day of July, 1917.
