4 An Ordinance to amend paragraph (e) of Section 11 and Sec-  
5 tion 19 of Ordinance No. 215 as passed by the Council of the  
6 18th day of October, 1917 and approved by the mayor on the  
7 18th day of October, 1917.

9 THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:-

10  
11 Section 1. That paragraph (e) of Section 11 of Ordinance No.  
12 215 as passed by the council on the 18th day of October, 1917  
13 and approved by the mayor on the 18th day of October 1917  
14 be and the same is hereby amended so as to read as follows.

15 (e) That No motor car or motor vehicle shall be driver in the  
16 city of Lebanon, Oregon with an unnecessary loud muffler, or  
17 an unnecessary loud out out open, or an unnecessary loud  
18 exhaust.

19 Section 2. That Section 19 of said Ordinance No. 215 be amend  
20 ed so as to read as follows:

21 Section 19: Any person or persons violating any of the provis-  
22 ions of this ordinance, shall upon conviction thereof or upon  
23 pleading guilty to any complaint for the violation thereof,  
24 ~~shall~~ be punished by a fine not exceeding Fifty Dollars for  
25 the first offense, or by imprisonment in the city jail not  
26 exceeding twenty-five days, and for the Second offense he  
27 shall be punished by a fine of not exceeding One Hundred Dol-  
28 lars, or by imprisonment in the city jail not exceeding Fifty  
29 days, and for the third offense or any subsequent offense he  
30 shall be punished by a fine of not exceeding One Hundred and  
31 Fifty Dollars or by imprisonment in the city Jail not exceed-  
32 ing seventy-five days or both such fine and imprisonment.
