An Ofdinance vacating a portion of "A" street and portions of certain alleys in center addition to Lebanon, Oregon, as follows: All the portion of "A" Street beginning at the Easterly line of Grove Street and extending Easterly to the Westerly line of Hiatt Street; also the Southerly 20 feet of the Alley intersecting Block 3; the Southerly 20 feet of the alley intersecting Block 1; the Northerly 20 feet of the alley intersecting Block 4; and the Northerly 20 feet of the alley intersecting Block 2, in Center Addition to Lebanon, Oregon.

WHEREAS, on the 3rd day of September, 1918, the Oregon & California Railroad Company, filed with the recorder of the city of Lebanon a petition asking that the following pertions of "A" Street and certain portions of the Alleys in Center Addition, to Lebanon be vacated, to-wit:-

All that portion of "A" Street beginning at the Easterly line of Grove Street and extending easterly to the westerly line of Hiatt Street, also the Southerly 20 feet of the alley intersecting Block 3; the southerly 20 feet of the alley intersecting Block 1; the Northerly 20 feet of the alley intersecting Block 4 and the northerly 20 feet of the alley intersecting Block 2 in Center Addition, to Lebanon, Oregon, and

WHEREAS, The Council of the said City of Lebanon, did on the said 3rd day of September 1918, pass and exact a resolution fixing as the time and place for hearing the said petition, and any remonstrances and objection thereto or the vacation of the said street and alleys, September 17th at the Council chambers in the city of Lebanon at the hour of 8 o'clock p.m. of said day, the said time be a regular meeting of the said council and

WHEREAS, The said Council did in the said resolution order and require the recorder of the City of Lebanon to give due and legal notice to all persons concerned, of the time and place and purpose of the said meeting, and

WHEREAS, The said recorder has filed with the said Council and in his office proof of the porting of the said notice and the giving of the notices required by the laws, charter and ordinances of the said city, and there being no remonstrances filed or made and no objections made or offered against the said petition or the vacations of the said street or alleys, and it appearing to the Council after due consideration and investigation that the said petitioner the Oregon and California Railroad Company owns all the land abutting upon the said portion of the said streets and alleys asked to be vacated, and is the only person effected by the vacation thereof, and that it is for the best interest of the said City and its inhabitants to grant the said petition and vacate the said portion of the said streets and alleys, NOW THEREFORE,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:



SECTION 1.- That all the following portions of "A" Street and alleys be and the same is hereby vacated, and the land therein described become the property of the abutting land owner, the Oregon & California Hailroad Company, to-wit:

All that portion of "A" Street beginning at the easterly line of Brove Street and extending Easterly to the westerly line of Hiatt Street, also the Southerly 20 feet of the alley intersecting Block No. 3; the Southerly 20 feet of the alley intersecting Block No. 1; the Northerly 20 feet of the Alley intersecting Block No. 4 and the Northerly 20 feet of the alley intersecting Block No. 2 all in Center Addition, to Lebanon, Oregon.

SECTION 2. This ordinance passed by the unanimous vote of all members elected to the council taken by aye and nay vote on the roll call of the council and the vote entered in the journal of the County, this 17th day of September, 1918.
