AN ORDINANCE PROVIDING FOR THE PURCHASE OF ONE CHEVOLET TRUCK FOR FIRE TRUCK AND FIRE FIGHTING, FOR TH LEBANON FIRE DEPARTMENT FROM J. S. NORTHROP? AT A COST OF FIFTEEN HUNDRED DOLLARS AND TO PROVIDE FOR THE MANNER OF PAYING FOR SAME WITH THE ARRANTS OF THE SAID CITY OF LEBANON, OREGON.

THE PEOPLE OF THE CITY OF LEBANON DO ORPAIN AS FOLLOWS:

SECTION 1. That the Mayor and recorder of the City of Lebanon be and there are hereby empowered and directed to enter into a concract and agreement with J. S. Northoop for the purchase from the said J. S. Northrop Of One One AuneHalf ton Chevolet Truck chases for the use and the Lebanon Fire Department for and at the agreed sum and price of Fifteen Hundred, the said sum to be paid as follows:

Five Hundred Dollars on the first day of January 1920, Five Hundren Dollars on the First Day of January 1921 and Five Hundred Dollars on the first day of January 1922. The said payment to Do by the warrant s of the said city of Lebanon, Oregon, to be issue and dated January 1st 11920, the said warrants to bear interest from the date of their issue until paid at the rate of six per cent per annum.

SECTION 2. the said last two warrants shall state upon their face the date they become due and that they shall bear interest at the rate of six per cent per annum, the interest to be paid semi_annually, on the first day of July and the first day of January until both of said warrants are fully paid. 26
