ORDINANCE NO. 25/ 2

AN ORDINANCE TO REGULATE THE BURNING OF REFUSE WITHIN THE FIRE LIMITS 3 OF THE CITY OF LEBANON, OREGON. AND THE DISPOSITION OF ASHES.

THE PEOPLE OF THE CITY OF LEBANONDO ORDAIN AS FOLLOWS. 5

SECTION 1 It shall be unlawful for any person, or persons, firm 7 or corporation, to burn any trash, lumber, leaves, straw, saw dust 8 or any other combustbble material in any street, alley or vacant 9 lot within the fire limits of the City of Lebanon, Oregon, any lot or alley adjacent to the fire limits of said city, except by permit issued in writing by the chief of the fire department of the said city, and then only under sich restrictions and safe guards as he may designate.

SECTION 2. No ashes shall be deposits in and wooded box, barrel or other wooden receptagle, within the fire limits of the said city and the same shall not be deposited in any wooden receptacles in any other part of the said city within ten feet of any building, or within ten feet of any other combustible material or dry grass.

SECTION 3. It shall be the duty of the chief of police and every police of icer, the shief of the fire department and every active fireman to report to the City attorney any violation of this ordinance, and it shall be the duty of the city attorney forxeex to file a complaint signed by the shief of police against any person re orted to him as herein provided, charging a violation of this ordinance, and such person shall be duly prosecuted.

SECTION 4. than person, firm or corporation violating any of the the Mayor this 5th oug of December, 1919 provisions of this ordinance, or buring any trash, rubbish or other things herein prohibited in violation of this ordinance or without first tprocuring a permit to do so shall upon conviction thereof OT LOF before the recorder's Court of the City of Lebanon be punished by
