2 ORDINANCE NO. 251

3 AN ORDINANCE TO REGULATE THE BURNING OF REFUSE WITHIN THE FIRE LIMITS
4 OF THE CITY OF LEBANON, OREGON. AND THE DISPOSITION OF ASHES.

5 THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS.

6 SECTION 1 It shall be unlawful for any person, or persons, firm
7 or corporation, to burn any trash, lumber, leaves, straw, saw dust
8 or any other combustible material in any street, alley or vacant
9 lot within the fire limits of the City of Lebanon, Oregon, or upon
10 any lot or alley adjacent to the fire limits of said city, except
11 by permit issued in writing by the chief of the fire department of
12 the said city, and then only under such restrictions and safe
13 guards as he may designate.

14
15 SECTION 2. No ashes shall be deposited in and wooded box, barrel
16 or other wooden receptacle, within the fire limits of the said city
17 and the same shall not be deposited in any wooden receptacle in
18 any other part of the said city within ten feet of any building,
19 or within ten feet of any other combustible material or dry grass.

20
21 SECTION 3. It shall be the duty of the chief of police and every
22 police officer, the chief of the fire department and every active
23 fireman to report to the City attorney any violation of this or-
24 dinance, and it shall be the duty of the city attorney ~~xxxxxx~~ to
25 file a complaint signed by the chief of police against any person
26 reported to him as herein provided, charging a violation of this
27 ordinance, and such person shall be duly prosecuted.

28 ~~Passed by the council this 5th day of December, 1919~~
SECTION 4. An person, firm or corporation violating any of the
29 ~~provisions of this ordinance, or burning any trash, rubbish or other~~
30 ~~things herein prohibited in violation of this ordinance or without~~
31 ~~first procuring a permit to do so shall upon conviction thereof~~
32 ~~before the recorder's Court of the City of Lebanon be punished by~~
