2 ORDINANCE NO. 258

3 An Ordinance to amend Section 19 of Ordinance No. 33 passed by
4 the Council of the City of Lebanon, Oregon, on the 23rd day of
5 February 1894 and approved by the Mayor of the said City of the
6 23rd day of February, 1894, Entitled " AN ORDINANCE CONCERNING
7 OFFENCES AND DISORDERLY CONDUCT, DEFINING WHAT SHALL CONSTITUTE
8 THE SAME; AND PROVIDING FOR THE PUNISHMENT THEREOF!"

9 THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

10 Section 1- That Section 19 of Ordinance No. 33 passed by
11 the council of the 23rd day of February 1894, and approved by
12 the Mayor of the City of Lebanon on the 23rd day of February
13 1894 Entitled "An Ordinance ~~xxxxxxx~~ concerning offenses and
14 disorderly conduct, defining what shall constitute the same
15 and providing for the punishment thereof be and the same is
16 hereby amended so as to read as follows:-

17 Section 19. It shall be unlawful for any person or persons, to *lead or*
18 drive any animal, or stock of any kind, on or over any side
19 walk in the City of Lebanon, or to drive any wagon, truck, auto-
20 mobile, buggy, or any vehicle of any kind or motor car or motor
21 vehicles, over or on any side walk or over or on any lawn, lot o
22 or tract or parcel of land without the consent of the owner of
23 such lot, lawn, or tract of land, and no person shall suffer or
24 permit any animal or stock which he or they may be driving or *lead*
25 *ing* ~~to~~ or which is in his his care or custody to go upon or over
26 any side walk or go ~~se~~ over or on any lawn. lot or tract of land
27 of any person without the consent of the owner of such *lot* or
28 lawn. Any tenant or renter who shall direct any person to drive
29 any truck, or other vehicle over any side walk, or to drive the
30 same on or over any lot or on or over any lawn without the consent
31 of the owner of such lawn, lot and tract or land, shall be equally
32 guilty with the person so driving the same over same.

1 Any person violating any of the provisions of this ordinance
2 shall be deemed guilty of a misdemeanor and upon conviction
3 thereof before the recorder's Court of the City of Lebanon,
4 Oregon, shall be punished by a fine not exceeding \$50.00 or
5 be imprisonment in the City Jail not exceeding 25 days.
