AN ORDINANCE TO REGULATE THE MANNER AND PLACES OF PARKING AUTOMOBILES AND OTHER VEHICLES ON THE STREETS OF LEBANON, OREGON, AND TO REGULATE THE LOADING AND UNLOADING OF VEHICLES ON MAIN STREET, and to repeal sections 1,2,3,4,5 and Paragraphs (j) and (l) OR ORDINANCE NO.215, AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE.

THE PEOPLE OF THE CITY OF LEBAHON DO ORDAIN AS FOLLOWS.

SECTION 1. All Vehicles and automobiles parked in the city of Lebanon shall be so parked that the right hand wheels of such vehicles and automobiles are not more than 18 inches from the curb or curb line, and the same shall be parked parallel with the curb or curb line and with the right side of the vehicle or automobile to the curb or curb line.

SECTION 2. No vehicle with a trailer attached shall be parked on Main Street within the fire limits of the said city, and no vehicle with a wheel base greater than 136 inches shall be parked on Main Street within the fire limits. No vehicle shall stand on Main street within the fire limits unless the same is parked as herein provided, except as provided in Section Three of this ordinance.

Section and parallel to the curb, except when handling or loading or unloading heavy freight, such as pianos, safes and such or similar articles, at which time they may back up with rear end to the curb, by first getting the permission of the marshal, recorder or Mayor to do so; and provided further that no vehicle shall be allowed to remain at one timexfame place for loading or unloading for more than 20 minutes at one time for one load, A team or animal drawn vehicle the team shall turne parallel with the curb and as close to the curb as possible while such vehicle is standing with end to curb and while loading or unloading, so as to take as little of the street towards the center as possible, which said team shall be headed in the direction of the trafic on such side of the street.

SECTION 4. No Automobile or other vehicle shall be parked or left standing within fifteen feet of any fire hydrant of the city of Lebanon, or the Lebanon Water system which is or may be used for fighting fires.

SECTION 5. All automobiles and other vehicles parked on those streets which have parking marking shall be wholly within the markings, and no part of the load, frame, bed or other part of the automobile or vehicle shall extend beyond the inner line of the park markings into the street.

SECTION 6. Sections, 1, 2, 3, 4, 5 and paragraphs (j) and (l) of ordinance No. 215 passed by the Council of the 18th day of October 1917 and approved by the mayor on the 18th day of October 1917 are hereby repealed, and all other ordinances and parts of ordinances in conflict with this ordinance are hereby repealed, and all parts of said ordinance No. 215 not hereby repealed and not in conflict herewith is hereby declared to be in full force and effect.

SECTION 7. That in as much as the City of Lebanon has no sufficient or effective parking ordinance at this time, and there is great danger of accident and death from lack or proper parking ordinances of the said city an emergency is hereby declared to exist and this ordinance shall be in full force and offect from and after its passage by the Council and approval by the mayor.

Passed by the Council this 25th day of July 1921, on roll call and vote taken by age and may vote and entered in the journal of the council proceeding all members elected to the council voting age on said roll call.

Approved by the Mayor this 26th day of July, 1921.
