

ORDINANCE BILL NO. 14 FOR 1924.

Ordinance No. 318

A BILL FOR

An ordinance amending Sections 1, 17 and 18 of Ordinance No. 111 of the City of Lebanon, Linn County, Oregon, relating to the licensing, regulating, taxing and restraining certain callings, trades and employments.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1: That Section 1 of Ordinance No. 111 be and the same is hereby amended to read as follows:

Section 1: Any person, firm or corporation, owning, operating or managing any play house or moving picture theater within the corporate limits of the City of Lebanon, Linn County, Oregon, shall pay a license therefor as follows, to-wit: For one day \$2.00; for one week \$6.00; for one quarter \$15.00; and for one year \$50.00. *Copy* Except as hereinafter, in this ordinance provided, all traveling tent shows, theatrical troupes, carnivals, medicine shows, and all other like transient performers or their managers, agents, or proprietors, before showing or performing within the corporate limits of the city of Lebanon shall pay therefor to the City Recorder a license as follows to-wit: For one day \$50.00; for one week \$250.00; for one quarter \$500.00; provided, however, that any person who owns or operates any moving picture theater or other regular licensed theater may give theatrical performances in connection therewith in whole or in part without paying any additional license than herein provided for moving picture shows.

Section 2: That Section 17 of Ordinance No. 111 of the City of Lebanon, Linn County, Oregon, be and the same is hereby amended to read as follows:

Section 17: The keeper or proprietor of every circus shall pay a license of Twenty (20) Dollars for each and every exhibition given by such circus within the corporate limits of the said city. The

keeper or proprietor of any side show accompanying any circus and charging an admission fee, shall pay a license of Four (4) Dollars for each night's performance. Every building, tent, space or area where feats of horsemanship, or acrobatic sports are exhibited shall be regarded as a circus under the provisions of this ordinance.

Section 3: That Section 18 of Ordinance No. 111 of the City of Lebanon, Linn County, Oregon, be and the same is hereby amended to read as follows:

Section 18: Dog and pony shows, or exhibitions and feats by trained animals shall pay a license as follows: Where all the performers are animals, for a one ring show, \$5.00 for each performance, and where there are two or more rings \$10.00 for each performance. Side shows with a dog and pony show or trained animal exhibition shall pay a license the same as a side show with a circus.
