Ordinance Bill No. 320

A BILL

Authorizing and directing the payment to C. E. Davis for repairs of Streets,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1: WHEREAS, the Committee on Streets and Public Property were authorized and directed to negotiate with certain persons for the repair of the paved streets of the City of Lebanon, and, Whereas, the said street committee procured one C. E. Davis to make certain repairs on the street, which repairs have been made in a satisfactory manner and the said C. E. Davis has rendered his bill to the City of Lebanon for the sum of ONE HUNDRED NINETY-SEVEN AND 40/100 DOLLARS for said repairs.

THEREFORE, the City Recorder is hereby authorized to issue a warrant in favor of said C. E. Davis against the ^{Street Improvement} general fund of the city of Lebanon for the sum of ONE HUNDRED NINETY-SEVEN AND 40/100 DOLLARS in payment of said bill.
