

ORDINANCE BILL NO. 14 FOR 1925.

ORDINANCE NO. 332.

A BILL for an ordinance authorizing the Mayor and Recorder of the City of Lebanon, Linn County, Oregon, to enter into a contract with Guy F. Pile for the improvement of Second Street from the South line of Grant Street to the North line of Tangent Street in Lebanon, Linn County, Oregon, and declaring an emergency.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

WHEREAS by ordinance No. 331 of the City of Lebanon, Linn County, Oregon, it was ordered that Second Street from the South line of Grant Street to the North line of Tangent Street in said City of Lebanon, Linn County, Oregon, be improved in the following manner to-wit:-

1. By grading said street to the proper sub-grade
2. By paving said street, full width, from curb line to Curb line, with either:
 - (a) Asphaltic concrete 2 inch top on 4 inch crushed rock or crushed gravel base;
 - (b) Portland cement concrete, six inches thick;
 - (c) Portland cement concrete, seven inches thick;
 - (d) Warrenite-bitulithic 2 inch top on 4 inch crushed rock base;
 - (e) Warrenite-bitulithic 1½ inch top on 3½ inch bituminous base.
3. By constructing curbs.
4. By paving headers.
5. By constructing inlets.
6. By laying vitrified sewer pipe.
7. By tapping sewers, and such other work as may be necessary for the proper improvement of said street,

said improvement to be made in accordance with the charter and ordinances of the said City of Lebanon, Linn County, Oregon,

and the plans, specifications and estimates of Engineer K.A. Sinclair, then on file with the Recorder of said City of Lebanon, Linn County, Oregon; and

WHEREAS it was provided in said ordinance that the Recorder of the said City of Lebanon, Linn County, Oregon, give notice calling for bids, for the making of said improvement, in the manner provided by law and by said ordinance; and

WHEREAS after due notice and advertisement for bids, made and given by said Recorder of said City of Lebanon, Linn County, Oregon, according to law and the ordinance last aforesaid, to-wit, on the 21st day of July, 1925, Guy F. Pile presented to the Council of Lebanon, Linn County, Oregon bid for making said improvement with Warrenite-Bitulithic 1½ inch top 3½ inch bituminous base, which said bid was made in due form and in conformity with all the conditions imposed by law and required by the Council of said City of Lebanon, Linn County, Oregon, by which said bid the said Guy F. Pile proposed to furnish all materials and implements and perform the labor necessary to make the above described improvement with the type of pavement know as Warrenite-Bitulithic 1½ inch top 3½ inch bituminous base, for the following named prices, to-wit:-

AND, WHEREAS said Guy F. Pile was the lowest and best responsible bidder for said proposed work and his said bid was the lowest and best responsible bid made therefor; It is ordained as follows:

Section 1. That the bid of Guy F. Pile for said improvement of said portion of said Second Street with the type of pavement known as Warrenite-Bitulithic 1½ inch top 3½ inch bituminous base be and the same is hereby accepted and the Mayor and Recorder of said City of Lebanon, Linn County, Oregon, are hereby authorized and directed to enter into a contract in writing with the said Guy F. Pile for the making of said improvement, with Warrenite-Bitulithic 1½ inch top 3½ inch Bituminous base, for and on behalf of the City of Lebanon, Linn County, Oregon, upon the terms in said bid herein above mentioned.


Section 2. Said contract shall provide further that the work shall commence within ten days after the execution of said contract and shall be prosecuted with such vigor that all of said work embraced in said contract shall be entirely completed on or before the first day of October, 1925, and the City of Lebanon, Linn County, Oregon, shall be deemed to suffer damages to the extent of twenty-five Dollars per day for each and every day the work is delayed and remains unfinished beyond said specified time and the said Guy F. Pile be required to furnish a bond in a sum equal to the amount of the bid of said contractor, to be approved by the Mayor of the City of Lebanon, Oregon, having as surety thereon some Surety Company authorized to do business in the State of Oregon, conditioned for the faithful performance of said contract on the part of the said Guy F. Pile, and further indemnifying the said City of Lebanon, Linn County, Oregon, against any claim or lien

for labor, work or material on the part of any person, firm or corporation arising out of said contract.

Section 3. Whereas it is necessary for the public peace, health and safety of the people of the City of Lebanon Linn County, Oregon, that the foregoing described improvement be immediately constructed, and an emergency is therefore deemed to exist and one is hereby declared to exist and this ordinance shall go into full force and effect immediately upon its passage by the council and approval by the Mayor.
