ORDINANCE NO. 337

A BILL FORAN ORDINANCE To ascertain and determine the probable cost of that certain improvement which the Council of the City of Lebanon, Oregon, has determined in Resolution No. 11, adopted by the City Council on the first day of May, 1925, to make on Main Street from the South line of Carolina Street to the North City Limits in Lebanon, Linn County, Oregon; to ascertain, assess, determine and declare the proportionate share of the cost of such improvement of said part of Main Street that is assessed upon each lot or part thereof abutting upon and adjacent to said part of said street to be so improved and which is especially benefited thereby; to declare that the engineering, legal, advertising and bonding fees are a part of the cost of the improvement of said street to be assessed against the property abutting upon, adjacent to and especially benefited by said improvement; and to direct the Recorder of said City to enter a statement of such assessment in the Docket of City Liens as provided by the charter of said city.

WHEREAS, on the 3rd day of March, 1925, the Council of the City of Lebanon, Linn County, Oregon, duly adopted Resolution No. 1 for 1925 requiring the City Engineer, or such other competent and Engineer as the City Council might select, to make plans, specifications for the improvement of Main Street in Lebanon, Linn County, Oregon, from the South line of Carolina Street to the North City Limits of said city by paving the same as in said Resolution specified, and the estimates of the work to be done and the probable cost thereof, and

WHEREAS, the City Council of Lebanon, Linn County, Oregon, pursuant to said Resolution No. 1, employed one K. A. Sinclair, a

competent Engineer to prepare plans, specifications and estimates of the work and the cost thereof, as provided in said Resolution; and

WHEREAS, the said Engineer, pursuant to said Resolution No. 1, made plans, specifications and estimates as directed by said Resolution for the improvement of said part of said Main Street in the manner specificied in said Resolution No. 1 and filed said plans, specifications and estimates in the Recorder's Office of said City on the 2/ day of May, 1925; and

WHEREAS the said Council, on the first day of May, 1925, by Resolution No. 9, duly adopted said plans, specifications and estimates of cost and, on said date, by Resolution No. 11 for 1925, determined and resolved that it deemed it expedient to improve said part of said Main Street in said City of Lebanon, Linn County, Oregon, in accordance with said plans, and specifications so made and filed as above specified; and

WHEREAS in and by said Resolution No. 11 for 1925 adopted as aforesaid, the Recorder of said City was duly ordered and directed to give notice of said proposed improvement of said part of said Main Street in said City of Lebanon from the South line of Carolina Street North to the North City Limits of said city as provided by the charter of said city of Lebanon, and

WHEREAS, the Recorder in pursuance of said order and direction of the said City of Lebanon, did duly give notice of said proposed improvement of said part of said Main Street in the manner provided by the Charter of said city, which said notice specificied the probable cost of the several classes or types of improvement provided for in said plans and specifications; and

WHEREAS, on the End day of June, 1925, the said Council duly passed Ordinance Bill No. 9 for 1925, Ordinance No. 328, providing for the time and manner of improving said part of said Main Street; providing how the cost of the same shall be paid, the penalty or damage to the City of Lebanon by the person or persons making such improvement

if the same shall not be completed within the time agreed upon; providing for the giving of a good and sufficient bond and providing for the giving by the Recorder of said City of notice for bids for said improvement, and

whereas, on the 24th day of June, 1925, the said Council of said City of Lebanon duly and regularly adopted Resolution No. 16 for 1925, after receiving bids for said improvement, determined that said improvement be made by paving said street with Warrenite-Bitulithic $1\frac{1}{2}$ " top, $3\frac{1}{2}$ " Bituminous base, according to said plans and specifications of said Engineer K. A. Sinclair, and

WHEREAS the said City Engineer has duly made and filed with the Recorder of said City of Lebanon an Assessment Roll for said improvement, showing the exact proportionate share of cost of said improvement that should be borne by each separate lot or tract of land abutting upon, adjacent to and especially benefited by said improvement, and

WHEREAS, pursuant to OrdinanceBill No. 1 for 1925, Ordinance No. 334, passed by the Council on the st day of July, 1925, notice was duly given to all persons owning property abutting upon, adjacent to and especially benefited by said improvement that the saidCouncil would, on the 4th day of August, 1925, at the Council Chambers of said Council at 7:30 o'clock P.M., levy an assessment on each lot or parcel of land abutting upon, adjacent to and especially benefited by said improvement, its proportionate share of the cost thereof.

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That the total cost of the improvement of said part of said Main Street with Warrenite-Bitulithic pavement, as above

specified to be borne by the owners of property abutting upon, adjacent to and especially benefited thereby is the sum of \$/6,266.28

Section 2. It is hereby determined that the Engineering, legal, advertising and bonding costs are a part of the costs of said improvement to be paid by said property owners.

Section 3. That the proportionate share of said cost of said improvement of said part of said lain Street to be assessed upon said lot or part thereof abutting upon, adjacent to and especially benefited thereby is hereby ascertained and declared to be the sum set and placed immediate after the separate description of each of such lots or parts thereof and each of such lots or parts thereof is determined and declared to be benefited by said improvement in a sum equal to or greater than the amount herein to be assessed against the same as follows, to-wit:
