

ORDINANCE NO. 3 FOR 1930.

ORDINANCE BILL NO. 405.

A BILL for an Ordinance providing for the regulation of of public boxing and wrestling bouts within the City of Lebanon, Linn County, Oregon; to provide for the appointment of a boxing and wrestling commission and defining the duties thereof; to provide a penalty for the violation of the terms of this Ordinance and declaring an emergency.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1: The Mayor of the City of Lebanon is hereby authorized, directed and empowered to appoint a Commission, consisting of six members, two of which shall be, at all times, members of the City Council, which Commission shall be known and designated as the Boxing and Wrestling Commission of the City of Lebanon.

Section 2: Two of said members so appointed shall serve for a term of one year from the date of their appointment; two shall serve for a period of two years from the date of their appointment; and two shall serve for a period of three years from the date of their appointment, the Mayor to designate in his appointment the time when the terms of the several Commissioners shall expire; and thereafter the four members of the Commission, whose terms have not expires, shall elect by majority vote the successors to the Commission, whose terms have expires, provided that whenever a vacancy occurs by reason of the expiration of the term or resignation of a Commissioner who is a member of the Council, then such a vacancy shall be filled from the City Council so that, at all times, two members of said Commission shall be members of the Council.

Section 3: The election of all members of said Commission after the first appointment shall be confirmed by the Council before their election becomes permanent.

Section 4: DUTIES OF THE COMMISSION: It shall be the duty of said Commission to meet and elect a President, Vice President and Secretary forthwith at a time to be designated by the Mayor after the first meeting of the Commission. Thereafter the Commission shall meet at the call of the President, or upon request in writing of, at least, three members of the Commission. The Commission, at its first meeting, shall appoint a match-maker who shall superintend the matching of all boxers and wrestlers, subject to approval by the Commission.

Section 5: A majority vote of all members of the Commission shall be necessary to decide any matter brought before it.

Section 6: It shall be unlawful for any person, or persons; to promote any public boxing or wrestling match where an entrance fee is charged, unless permission is first had and received from the aforesaid boxing and wrestling commission.

Section 7: VACANCIES: All vacancies occurring in the membership of said Commission not herein above provided for shall be filled by the remaining Commissioners then in office.

Section 8: Any person, or persons, firm or corporation, violating any of the terms of this ordinance shall, upon the conviction thereof before the City Recorder, be punished by fine not exceeding One Hundred Dollars.

Section 9: In as much as there is now being promoted in the City of Lebanon certain boxing and wrestling bouts, it is deemed necessary for the protection of public peace, health and safety

The Matchmaker shall have the right to select the referee for any and all matches, which referee may be discharged by the commission upon good cause shown; and provided also that if either contestant shall be dissatisfied with the referee selected by the matchmaker he shall have a right to appeal to the Commission, and if the Commission thinks best it can then select one of its own choice.

of the people of Lebanon that this ordinance become immediately effective, therefore an emergency is declared to exist and this ordinance shall be in full force and effect from and after its passage by the Council and approval by the Mayor.
