ORDINANCE NO. 419

A BILL FOR AN ORDINANCE PROVIDING FOR AND CALLING A SPECIAL ELECTION TO BE HELD IN THE CITY OF LEBANON, LINN COUNTY, OREGON, ON THE 20TH DAY OF APR., 1931, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF LEBANON, LINN COUNTY, OREGON, A CHARTER AMENDMENT AUTHORIZING THE COMMON COUNCIL OF SAID CITY TO ISSUE, DISPOSE OF AND SELL THE INTEREST BEARING BONDS OF THE CITY OF LEBANON IN THE AMOUNT OF \$30,000.00 FOR THE PURPOSE OF REFUNDING CERTAIN OUTSTANDING SEWER BONDS OF SAID CITY; AND, ALSO, TO SUBMIT A CHARTER AMENDMENT CHANGING THE BOUNDARIES OF THE SAID CITY OF LEBANON; TO PROVIDE FOR THE GIVING OF NOTICE OF SUCH ELECTION; AND DECLARING AN EMERGENCY.

WHEREAS, heretofore and on the 17th day of March, 1931, the Common Council of the City of Lebanon, Linn County, Oregon, in regular meeting assembled, duly passed Resolution No. 4 for 1931, providing for the submission to the voters of said City of Lebanon a charter amendment authorizing the Common Council of the said City of Lebanon to issue, dispose of and sell certain interest bearing bonds of the City of Lebanon, Linn County, Oregon; and

WHEREAS, heretofore and on the 17th day of March, 1931, the Common Council of the City of Lebanon, Linn County, Oregon, duly adopted Resolution No. 5 for 1931, submitting to the voters of the City of Lebanon a charter amendment changing the boundaries of the said City of Lebanon; and

WHEREAS, the Council deems it advisable that each of said charter amendments, so submitted by the Council, should be submitted to the people for their approval or rejection at a special election to be called for that purpose, NOW, THEREFORE,

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. There shall be held in the City of Lebanon, Linn County, Oregon, on the 20th day of Apr., 1931, a special election for the purpose of submitting to the legal voters of



the said City of Lebanon, Linn County, Oregon, a charter amendment, amending the charter of the City of Lebanon, Linn County, Oregon, which was duly adopted by the legal voters of said City at the regular election held in said City on the 1st day of December, 1913, by adding a Section thereto, to be numbered 115A, which said Section shall read as follows:

Section 115A. For the purpose of refunding \$30,000.00 of the Sewer Bonds of said City of Lebanon now outstanding and which mature on the 1st day of June, 1931, for the payment of which no provision has heretofore been made, said City of Lebanon is hereby authorized, empowered and directed by and through its Common Council to issue, dispose of and sell the interest bearing bonds of the said City of Lebanon in the sum of \$30,000.00, which said bonds shall be in the denominations and mature at such dates as may be provided by the said Common Council, provided that no bond or bonds so issued under the provision of this Section shall draw a rate of interest in excess of six per cent. per annum; and provided further that the manner and date of paying interest on said bonds, the rate thereof and the provision for the retirement thereof to be left to the discretion of the Common Council of said City of Lebanon; provided further that the debt limit, provided by the charter of the said City of Lebanon, shall not apply to the bonds hereby authorized; and provided further, that the Council shall provide annually a special tax levy against all the property within the corporate limits of said City sufficient to pay the interest to accrue on said bonds and to pay the principal thereof as the same becomes due.

Also, to submit to the legal voters of the said City of Lebanon, Linn County, Oregon, a charter amendment to amend Section 10, Article 3, Chapter 1, of the charter of the City of Lebanon, Linn County, Oregon, as adopted at the general



election held in the City of Lebanon on the 1st day of December, 1913, so that said Section 10 shall read as follows:

Section 10. The limits of the City of Lebanon shall be as follows: Beginning on the South boundary line of and East 21 chains distant from the Southwest corner of the donation land claim of H. R. Greer, same being Notification No. 2296 and Claim No. 47 in Township No. 12 South of Range 2 West of the Willamette Meridian, in Linn County, Oregon, and running thence South 250 feet; thence due West 1089 feet to a point which is East 297 feet and South 250 feet from the Southwest corner of the H. R. Greer Donation Land Claim; thence South 1 foot; thence West 130 feet; thence South 90 feet; thence East 130 feet; thence North 89 feet; thence East 1089 feet; thence South 473 feet; thence West 14.60 chains; thence North 68 degrees 15 minutes West 3.50 chains; thence North 86 degrees 45 minutes West 1.50 chains; thence South 81 degrees 30 minutes West 2.50 chains; thence West 2.50 chains; thence North 63 degrees 45 minutes West 5.50 chains; thence South 87 degrees West 6.75 chains; thence South 68 degrees 45 minutes West 4 chains; thence South 77 degrees 20 minutes West 9 chains; thence North 80 degrees 30 minutes West 2 chains; thence North 65 chains 15 minutes West 2 chains; thence North 45 degrees 30 minutes West 2.50 chains; thence North 30 degrees, West 3.50 chains; thence North 65 degrees West 3 chains; thence West 25.60 chains to a point which is East 22 links distant and South 6 chains distant from the Northwest corner of the North ell of the donation land claim of Russell T. Hill and wife, the same being Notification No. 2342 and Claim No. 77 in said Township and Range; thence North 113.70 chains; thence East 58.25 chains; thence South 7 degrees East 3 chains; thence South 18 degrees East 4 chains; thence South 1 degree and 30 minutes West 13.00 chains; thence South 57 degrees East 5 chains;



thence South 19 degrees East 3.57 chains; thence South 30 degrees East 4.25 chains; thence South 42 degrees 30 minutes East 7.80 chains; thence South 39 degrees East 4 chains; thence South 65 degrees and 5 minutes East 9.78 chains to a point due North of the place of beginning; thence South 65.12 chains to the place of beginning, all in Linn County, Oregon.

Section 2. The Recorder of the City of Lebanon, Linn County, Oregon, is hereby directed to give due and legal notice of the special election to be held as provided for in Section 1 of this Ordinance, by causing a notice thereof to be published once a week for two successive weeks in the Lebanon Express, a newspaper of general circulation, published within the said City of Lebanon, within thirty days next preceding the date of such election, which said notice shall state the date on which said election shall be held, the polling places therefor, the hours during which said polling places will be open, and the measures to be voted on, and such other things as may be required by the charter of the said City of Lebanon relating to special elections.


Section 3. The Council finds and determines that the \$60,000.00 issue of Sewer Bonds of the said City of Lebanon becomes due and payable on June 1st, 1931, and that there is not sufficient money in the City Treasury with which to pay the entire amount of said sum and that it is necessary to call a special election to authorize the Council to borrow money with which to pay said indebtedness and, in order that said money may be available when said bonds become due, it is necessary that said election be held at the earliest possible moment and this Ordinance is therefore deemed necessary for the immediate preservation of the peace, health and safety of the City of Lebanon. This Ordinance shall therefore become




immediately operative upon its passage by the Council and approval by the Mayor.

Passed by the Council this 17th day of March, 1931, the same having received the unanimous vote of all the members of the Council.
