ORDINANCE NO. ⁴³⁰~~429~~

A BILL FOR AN ORDINANCE levying an assessment against all the taxable property in the City of Lebanon, Linn County, Oregon, for the year 1932.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

WHEREAS, on the ¹¹20th day of October, 1931, the Common Council, acting with six freeholders, chosen from the several wards of the City as by law required, prepared an estimate or budget of all money necessary to be raised by taxation for the year 1932 for the purpose of conducting the business of the City of Lebanon for said year; and

WHEREAS, Tuesday, November 17th, 1931, was set for the hearing of said budget and whereas notice of such hearing was duly given, as by law required, and said hearing was, on said date and at the time and place in said notice given, duly and regularly held; and

WHEREAS, a full and complete hearing was had upon said tentative budget and the Council, being the levying board of the City of Lebanon, being now fully advised as to the amount necessary to be raised by taxation for all purposes of said City for the year 1932, which said amounts are as follows:
