## ORDINANCE NO. 431

A BILL FOR AN ORDINANCE DECLARING A PART OF ELMORE STREET TO BE A SAFETY SCHOOL ZONE; REGULATING THE SPEED, OPERATION AND CONTROL OF MOTOR VEHICLES ENTERING INTO AND PASSING THROUGH SAID SAFETY ZONE; PROVIDING FOR THE ERECTION OF SAFETY SIGNS AND PROVIDING A PENALTY FOR THE VIOLATION OF THIS CRDINANCE.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section I. All that part of Elmore Street extending from the East line of Main Street to the West line of Williams Street in Lebanon, Linn County, Oregon, is hereby declared to be a safety school zone.

Section II. In view of the fact that said part of Elmore Street is a narrow thoroughfare and that the school ground of one of the public schools of Lebanon, to-wit: Queen Anne School, abuts upon and is adjacent to the South line of said part of Elmore Street, and, whereas, two or three hundred school children attend said school and traverse said thoroughfare, and that there is danger of motor vehicles, traveling upon said thoroughfare, injuring some of said children, therefore said part of said Street is hereby declared to be a dangerous thoroughfare and the maximum speed for all motor vehicles traveling along and upon said thoroughfare shall be smiles per hour between the hours of eight o'clock in the foremoon and four o'clock in the afternoon on school days.

Section III. There shall be erected in said Elmore Street at or approximately at the Northwest corner of said school grounds a sign with the word "Stop" plainly painted or embossed thereon with letters of sufficient size to be easily seen and read by persons approaching the said school grounds in a motor vehicle, which said sign may, also, contain other matters

written or printed thereon, such as designating the speed limit and the hours during which the limitation applies, and a like sign shall be placed in Elmore Street at or about the intersection of said Elmore Street with Grove Street; and it shall be unlawful for any motor vehicle to enter that part of said Elmore Street located between said two signs, without first coming to a complete stop.

Section IV. Any person or persons violating any of the provisions of this ordinance shall, upon conviction thereof before the City Recorder, be fined in a sum not less than
