ORDINANCE NO. 434

A BILL FOR AN ORDINANCE REGULATING THE NUMBER OF CARNIVAL COMPANIES, THEATRICAL TROUPES AND OTHER TRAVELING SHOWS THAT MAY OPERATE OR SHOW WITHIN THE CORPORATE LIMITS OF THE CITY OF LEBANON AT ANY ONE TIME.

WHEREAS carnival companies, theatrical troupes and other traveling shows are likely to have in company with them, though not a part of their own company, persons who are likely to cause disturbances and breaches of the peace and thus require extra police regulation, and

WHEREAS the police officials of Lebanon are not sufficient in number to adequately police more than one such carnival, theatrical troupe or other traveling show,

NOW, THEREFORE, THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section One. A carnival company as used and referred to in this ordinance shall be and is defined to be one or more persons who travel from place to place and carry with them such manner of amusement as "Merry-go-round", "Ferris Wheel" and/or other forms of amusement and may or may not be accompanied by side shows or exhibitions.

Section Two. Side shows or other theatrical troupes, when accompanying any such carnival company as defined in Section One of this Ordinance, shall not be limited in number if they be under the supervision of such carnival company.

Section Three. No carnival company, theatrical troupe or other traveling show shall be permitted to set up, exhibit or operate within the corporate limits of the City of Lebanon, Linn County, Oregon, without first making application to and

receiving a permit from the License Committee of the Common Council, and, if any such permit be granted, such company or other show shall not then operate until the license fee has been duly paid as provided by Ordinance No. 111 of the City of Lebanon as amended.

Section Four. No such permit shall be granted or license issued for more than one such carnival company, theatrical troupe or other traveling show to exhibit or operate within the corporate limits of the City of Lebanon at any one time until such time as the population of the City shall reach 2500 or more, and no such permit shall issue or license be granted for any such carnival company, theatrical troupe or other traveling show which, in the judgment of the said License Committee, is not fit or proper to exhibit in said City; and the said License Committee, in all cases, reserves the right, after any such license is granted, to revoke the same when in its judgment the said exhibition of said carnival company, theatrical troupe or other traveling show shall become unfit or improper to exhibit in said City, and the members of said License Committee shall be the exclusive judges of whether or not such exhibition is or is not proper to exhibit in said City, subject only to the right of appeal to the Common Council as hereinafter provided.

Section Five. Should more than one application for such license be pending at one time, the License Committee of the Council shall determine which, if any, of said applications for a license be granted.

Section Six. Should the said License Committee refuse to issue a permit to any such carnival company, theatrical troupe or other traveling show, or should they revoke any license theretofore granted to any such carnival company,

theatrical troupe or other traveling show, the manager or other officer of such carnival company, theatrical troupe or other traveling show is hereby given the right of appeal to the Common Council of the said City at the next regular meeting thereof, and the decision of the Common Council on such appeal shall be final.

Section Seven. Nothing in this ordinance contained shall be deemed to repeal any part of any license ordinance of the City now in force, except such part thereof as may be in direct conflict herewith.
