

ORDINANCE BILL NO. 5 FOR 1933.

ORDINANCE NO. 442

A BILL FOR AN ORDINANCE TO AMEND SECTION 8 OF ORDINANCE NO. 111 OF THE CITY OF LEBANON, LINN COUNTY, OREGON, ENTITLED "AN ORDINANCE TO LICENSE, REGULATE, RAX AND RESTRAIN CERTAIN CALLINGS, TRADES AND EMPLOYMENTS IN THE CITY OF LEBANON, IN LINN COUNTY, OREGON, AND TO DEFINE WHAT SHALL CONSTITUTE THE SAME, AND TO PROVIDE FOR THE MANNER OF ISSUING LICENSES THEREFOR, AND TO PROVIDE FOR THE PUNISHMENT OF ANY VIOLATION OF THIS ORDINANCE, AND TO REPEAL ORDINANCES NO. 54, 66, 71, 90 and 92, AND ALL OTHER ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE".

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

1. That Section 8 of said Ordinance No. 111 of the City of Lebanon shall be amended to read as follows:

Section 8. That any person, firm or corporation owning, operating or keeping any billiard or pool room or other room or place where any billiard table, pool table or combination billiard-pool table is kept in the City of Lebanon for profit or hire or for which a charge is made or exacted for the playing thereon, shall pay a minimum annual license fee of Fifty Dollars (\$50.00) for five tables or less, and Ten Dollars (\$10.00) per annum for each additional table over five; provided that said license fee shall be paid semi-annually in advance on January 1 and July 1 of each year hereafter, beginning July 1, 1933; provided that no license shall be taken out or granted for a longer period than one year nor for a shorter period than six months; and provided further that one license shall cover no more than one place of business of any such person, firm or corporation. One-half of the annual license fee shall be paid for any license issued for six months. No more than one license shall be issued for each one thousand inhabitants, or fractional part thereof, residing within the corporate limits of the City of Lebanon. Before any

such tables are used in the said City of Lebanon, the owner, proprietor or keeper thereof shall first procure a license therefor, as provided in said Ordinance No. 111 and amendments thereto, and pay the license fee herein provided.
