ORDINANCE NO. 446

A BILL FOR AN ORDINANCE TO AMEND ORDINANCE NO. 26 PASSED BY THE COUNCIL AND APPROVED BY THE MAYOR ON THE **20th** DAY OF SEPTEMBER, 1892, ENTITLED " AN ORDINANCE GRANTING UNTO C. G. RAWLINGS, HIS SUCCESSORS OR ASSIGNS, THE RIGHT TO ERECT AND MAIN-TAIN A SYSTEM OF ELECTRIC LIGHTS IN THE CITY OF LEBANON, OREGON" AND TO REPEAL ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS: Section 1. That Ordinance No. 26 passed by the Council and approved by the Mayor on the 20th day of September, 1892, and entitled "An ordinance granting unto C. G. Rawlings, his successors or assigns, the right to erect and maintain a system of electric lights in the City of Lebanon, Oregon" be and the same is hereby amended by the addition of a section, which shall be Section 5A and shall read as follows:

Section 5A. That the rights, privileges and franchises hereby

granted shall continue in force until September 1, 1933, and shall thereafter cease.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 5A. That the rights, privileges and franchises hereby granted shall continue in force until September 1, 1933, and shall thereafter cease.

Section 2. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
