

ORDINANCE BILL NO. 11 FOR 1933

ORDINANCE NO. 447

A BILL FOR AN ORDINANCE TO AMEND SECTION 1 OF ORDINANCE NO. 276 OF THE CITY OF LEBANON, ENTITLED "AN ORDINANCE REGULATING THE CONSTRUCTION, ERECTION, RAISING, LOWERING, ALTERATION, REPAIR AND USE OF BUILDINGS, AND TO PROVIDE FOR PROTECTION AGAINST FIRES, AND TO DEFINE AND PRESCRIBE THE FIRE LIMITS OF THE CITY OF LEBANON, OREGON, AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE, AND DECLARING AN EMERGENCY."

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

That Section 1 of Ordinance No. 276 of the City of Lebanon, passed by the Council on the 27th day of June, 1921, and approved by the Mayor on the 27th day of June, 1921, be and the same is hereby amended to read as follows:

BUILDING PERMITS, BY WHOM ISSUED:

Section 1. It shall be unlawful for any person, firm or corporation to erect, enlarge or materially repair any building within the corporate limits of the city of Lebanon, Oregon, regardless of the cost thereof, or build, raise, lower, alter or repair any building within the fire limits of the said City of Lebanon without first obtaining a permit therefor. Any firm, person or corporation desiring to construct any building within the fire limits of said city of Lebanon, or to raise, lower, alter or repair any building or structure or structures, including wooden buildings, within the city limits shall, before commencing such work, file with the recorder copies of the plans and specifications of the proposed construction, raising, lowering, alteration or repair as the case may be, and shall present therewith an application in writing for permission to do such work. Such application shall designate the location of such building or proposed structure and with the plans and specifications shall be referred by the recorder to the Committee on Streets and Public Property of the Common Council of the said city. If the said plans and specifications be for the construction
