

ORDINANCE BILL NO. 10 FOR 1934.

ORDINANCE NO. 457

A BILL FOR AN ORDINANCE LEVYING AN ASSESSMENT AGAINST ALL THE TAXABLE PROPERTY IN LEBANON, LINN COUNTY, OREGON, FOR THE YEAR 1935.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

WHEREAS, on the 11th day of September, 1934, the Common Council, acting with six freeholders chosen from the several wards of the City, as by law required, prepared an estimate or budget of all money necessary to be raised by taxation for the year 1935 for the purpose of conducting the business of the City of Lebanon for said year; and

WHEREAS, Tuesday, October 16, 1934, was set for hearing of said budget and notice of such hearing was duly given as by law required and said hearing was on said date and at the time and place in said notice given, duly and regularly held; and

WHEREAS, a full and complete hearing was had upon said tentative budget and the Council, being the levying board of the City of Lebanon, being now fully advised as to the amount necessary to be raised by taxation for all purposes of said City for the year 1935, which said amounts are as follows:
