A BILL FOR AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND THE RECORDER OF THE CITY OF LEBANON, OREGON, TO EXECUTE A QUIT-CLAIM DEED TO WALTER C. SMITH AND VERA E. SMITH, HUSBAND AND WIFE, ON BEHALF OF SAID CITY TO CERTAIN REAL PROPERTY OWNED BY SAID CITY.
