A BILL FOR AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND THE RECORDER OF THE CITY OF LEBANON, OREGON, TO EXECUTE QUIT-CLAIM DEEDS TO GEORGE W. HARDEN AND A. ENDERS, RESPECTIVELY, ON BEHALF OF SAID CITY TO CERTAIN REAL PROPERTY OWNED BY SAID CITY.

THE PEOPLE OF THE CITY OF LEBANON, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. That the Mayor and Recorder of the City of Lebanon, Oregon, be and they are hereby authorized, directed and empowered to execute a quit-claim deed to George W. Harden, for the purchase price of \$150.00, conveying to him the title of said city in and to the following described real property, to-wit:

Beginning at a point which is 365 feet North and 165 feet West from the Northeast corner of Lot No. 2 in Block No. 16 in Ralston's Second Addition to Lebanon, in Linn County, Oregon, and running thence North parallel with the west line of Main Street in said City, 60 feet; thence West 165 feet to East line of Second Street; thence South on east line of Second Street 60 feet; thence East 165 feet to the place of beginning, all in Lebanon, in Linn County, State of Oregon.



Beginning at a point which is 305 feet North and 165 feet West from the Northeast corner of Lot No. 2 in Block No. 16 in Ralston's Second Addition to Lebanon, in Linn County, Oregon, and running thence North parallel with the west line of Main Street in said City, 60 feet; thence west 165 feet to East line of Second Street; thence South on east line of Second Street 60 feet; thence East 165 feet to the place of beginning, all in Lebanon, in Linn County, State of Oregon.


Section 3. That said respective sales are hereby confirmed.
