A BILL FOR AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND THE RECORDER OF THE CITY OF LEBANON, OREGON, TO EXECUTE A SPECIAL WARRANTY DEED TO BERT L. COTTON, ON BEHALF OF SAID CITY TO CERTAIN REAL PROPERTY OWNED BY SAID CITY.

Section 2. That the sale of said parcel of real property to Bert L. Cotton is hereby in all respects confirmed.
