

ORDINANCE BILL NO. 7 FOR 1936

ORDINANCE NO. 477

A BILL FOR AN ORDINANCE TO PROHIBIT THE DRIVING, RUNNING OR OPERATING OF ANY AUTOMOBILE, TRUCK, MOTORCYCLE OR ANY OTHER MOTOR VEHICLE WHILE IN AN INTOXICATED CONDITION OR UNDER THE INFLUENCE OF INTOXICATING LIQUOR, AND PROVIDING A PENALTY FOR VIOLATION THEREOF.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person while in an intoxicated condition or under the influence of intoxicating liquor, to drive, operate or run, upon or over any highway, street or thoroughfare within the City of Lebanon, Oregon, any automobile, truck, motorcycle or any other motor vehicle.

Section 2. Any person who shall drive, operate or run any such motor vehicle upon or over any highway, street or thoroughfare, within the City of Lebanon, Oregon, while intoxicated or under the influence of intoxicating liquor, upon conviction thereof in the Recorder's Court, shall be fined in a sum not exceeding \$100.00 or be imprisoned in the city jail not exceeding ten days, or be punished by both such fine and imprisonment.

Section 3. This Ordinance being necessary for the immediate protection of the public peace, health, safety and morals, the same shall be in full force and effect from and after the date of its passage by the Council and approval by the Mayor.
