

ORDINANCE NO. 490 FOR 1937

AN ORDINANCE TO AMEND ORDINANCE NO. 276 OF THE CITY OF LEBANON ENTITLED, "AN ORDINANCE REGULATING THE CONSTRUCTION, ERECTION, RAISING, LOWERING, ALTERATION, REPAIR AND USE OF BUILDINGS, AND TO PROVIDE FOR PROTECTION AGAINST FIRES, AND TO DEFINE AND PRESCRIBE THE FIRE LIMITS OF THE CITY OF LEBANON, OREGON, AND TO REPEAL ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE, AND DECLARING AN EMERGENCY", BY THE ADDITION OF A SECTION TO BE KNOWN AS SECTION 1a, REPEALING ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF LEBANON DO ORDAIN AS FOLLOWS:

Section 1. That Ordinance No. 276 of the City of Lebanon passed by the Council and approved by the Mayor on the 27th day of June, 1921, be and the same is hereby amended by the addition thereto of the following section:


"Section 1a. That when any person shall propose to erect any building within the corporate limits of the City of Lebanon, Oregon, on or near the property line of the street or alley upon which the site for the proposed building abuts, he shall so indicate when making application for a building permit hereunder and shall pay to the City Recorder the sum of \$ 2.50 as the fee of the City Engineer for the establishment of said property line; that the City Engineer shall within a reasonable time thereafter establish and plainly mark said property line and the City Recorder shall pay to the City Engineer said fee of \$ 2.50 therefor; that no permit shall be issued for the erection of any building on or near the property line until said property line is established by the City Engineer, and it shall be unlawful for the applicant thereafter to erect the proposed building closer to the street or alley than the property line so established by the City Engineer.

Section 2. That all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 3. This ordinance being necessary for the immediate protection of the public peace, health, safety and morals, the same shall be in full force and effect from and after the date of its passage by the Council and approval by the Mayor.
