ORDINANCE NO. 503

AN ORDINANCE PROVIDING FOR THE CONSTRUCTION OF CURBS, CURB GUTTERS AND INTEGRAL CURBS AND GUTTERS, PROVIDING SPECIFICATIONS THEREFOR, REPEALING ORDINANCES IN CONFLICT HEREWITH, AND DECLARING AN EMERGENCY.

THE PEOPLE OF THE CITY OF LEBANON, OREGON, DO ORDAIN AS FOLLOWS:

Section 1. That except as herein provided all curbs built and constructed or replaced hereafter shall be constructed of cement, sand, and gravel in the proportions of 1, 2, and 4 mix and shall be made by the one-run process.

Section 2. That whenever any curb within the City of Lebanon shall be replaced or repaired, or a new curb constructed, either by voluntary action of the property owner or by Order of the Common Council of said City, as by Ordinances heretofore provided, and the owner of the property upon which said curb or proposed curb abutts shall desire to construct the same of wood, as by Ordinances heretofore provided, he shall make an application in writing to the Common Council, describing the premises upon which said curb or proposed curb abutts, and may therein request an Order of the Council to build a wooden curb in accordance with the Ordinances of said City; that if, in the judgment of said Council, it shall seem proper to repair said curb or build a new one out of wood, it may, by Resolution, grant said property owner the right to build the same.

visable that an integral curb and gutter, or curb gutter where a curb already exists, be built along any street of the City of Lebanon, it may, by Resolution, order the same to be built as in the manner provided for ordering sidewalks, curbs, and other street improvements, and shall, in like manner, levy assessments against the property upon which the same abutts,

provided, however, that said integral curb and gutter and curb gutter shall be constructed on the following specifications, to-wit:

INTEGRAL CURB AND GUTTER:

The curb portion shall be six (6) inches thick at the top and of sufficient depth to give a normal drop of six (6) inches from the top to the curb gutter, plus not less than seven (7) inches, being the minimum thickness of the curb gutter as hereinafter provided; on the street side of the curb there shall be a batter of three-fourths (3/4) inch to the gutter; and there shall be extended into the street for a distance of two (2) feet from the street side of the curb and poured integral with the curb, and of the same mix, a gutter not less than seven (7) inches in thickness with an inclining slope away from the curb, corresponding with the contour of the street.

CURB GUTTER:

That wherever there exists a cement curb in good condition and built on grade and according to specifications provided by Ordinances of the City of Lebanon at the time the same was constructed, a curb gutter may be built which will abutt tightly against the existing curb, and such curb gutter shall be of the same specifications and construction as provided hereinabove for the curb gutter portion of the integral curb and gutter.

Section 4. That whenever any property owner shall petition the Council for the right to build an integral curb and gutter, curb, or curb gutter, as herein provided, and shall agree to pay cash for the cost thereof or execute a bond under the Bancroft Bonding Act for the cost thereof, and shall waive the right of remonstrance, the service and publication of the notice to build, the calling for bids, and consent to the assessment of the real property upon which said curb and gutter shall abutt, the same shall be constructed by Order of said Council, if, in its judgment, it shall declare by Resolution such improvement to be advisable.

Section 5. That all Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 6. That financial aid from agencies of the Federal Government being available for the construction and replacement of curbs of said City, which aid may be recalled

at any time if prompt advantage thereof is not taken, and this Ordinance being necessary for the peace, health, and safety of persons and property of said City, an emergency is hereby declared and this Ordinance shall be in full force and effect from and after the date of its passage by the Council and approval by the Mayor.
